ENHANCING DECISION-MAKING EFFICIENCY

EACH QUESTION SHOULD BE STRAIGHTFORWARD AND FREE OF JARGON. SIMPLICITY ENSURES THAT RESPONDENTS INTERPRET THE QUESTIONS UNIFORMLY, WHICH ENHANCES THE RELIABILITY OF THE EVALUATION. AVOID COMPOUND QUESTIONS THAT MIGHT CONFUSE OR DILUTE THE FOCUS.

BALANCE BETWEEN BREADTH AND DEPTH
