ELIGIBILITY AND ENROLLMENT PROCESS

THE ENROLLMENT PROCESS IS COORDINATED THROUGH THE ILLINOIS DEPARTMENT OF CENTRAL MANAGEMENT SERVICES, WHICH PROVIDES RETIREES WITH DETAILED INSTRUCTIONS ON SELECTING AND ENROLLING IN HEALTH PLANS OFFERED BY AETNA. IT IS IMPORTANT FOR RETIREES TO ADHERE TO ENROLLMENT DEADLINES AND PROVIDE ALL REQUIRED DOCUMENTATION TO ENSURE TIMELY COVERAGE.

KEY ENROLLMENT PERIODS
