BY ARTICULATING PRIORITIES, AG GARLAND SETS EXPECTATIONS FOR FEDERAL PROSECUTORS AND LAW ENFORCEMENT AGENCIES NATIONWIDE.

LEGAL AND POLITICAL SIGNIFICANCE

COMMITMENT TO THE RULE OF LAW

A CENTRAL THEME IN AG GARLAND SPEECH IS THE UNWAVERING COMMITMENT TO THE RULE OF LAW. AG GARLAND EMPHASIZES THAT JUSTICE MUST BE ADMINISTERED FAIRLY, IMPARTIALLY, AND WITHOUT POLITICAL INTERFERENCE. THIS THEME UNDERSCORES THE IMPORTANCE OF AN INDEPENDENT JUDICIARY, DUE PROCESS, AND THE PROTECTION OF CONSTITUTIONAL RIGHTS.
