THIS RESTRICTS THEIR ABILITY TO ACCUMULATE ASSETS AND PARTICIPATE FULLY IN ECONOMIC ACTIVITIES. SOLUTIONS INCLUDE EXPANDING COMMUNITY DEVELOPMENT FINANCIAL INSTITUTIONS (CDFIs), PROMOTING INCLUSIVE BANKING PRACTICES, AND OFFERING MICROLOANS.

### FRAGMENTED AND SHORT-TERM FUNDING

INCONSISTENT OR PROJECT-BASED FUNDING OFTEN UNDERMINES THE SUSTAINABILITY OF ASSET BUILDING AND COMMUNITY DEVELOPMENT INITIATIVES. LONG-TERM INVESTMENTS AND COORDINATED FUNDING STREAMS ARE NECESSARY TO SUPPORT ONGOING PROGRAMS AND CAPACITY BUILDING. PARTNERSHIPS AMONG GOVERNMENT, PRIVATE SECTOR, AND NONPROFIT ORGANIZATIONS CAN ENHANCE RESOURCE MOBILIZATION.

### STRUCTURAL INEQUITIES AND POLICY BARRIERS

SYSTEMIC ISSUES SUCH AS DISCRIMINATORY LENDING, ZONING LAWS, AND UNEQUAL EDUCATION ACCESS POSE SIGNIFICANT OBSTACLES. ### CAPACITY CONSTRAINTS AND SKILL GAPS

LIMITED ORGANIZATIONAL CAPACITY AND INSUFFICIENT SKILLS AMONG COMMUNITY GROUPS CAN IMPEDE EFFECTIVE IMPLEMENTATION. PROVIDING TRAINING, TECHNICAL ASSISTANCE, AND LEADERSHIP DEVELOPMENT SUPPORTS STRONGER INSTITUTIONS AND BETTER OUTCOMES. COLLABORATION WITH EXPERIENCED PARTNERS CAN ENHANCE EXPERTISE AND RESOURCE SHARING.

COMMON ASSETS INCLUDE PHYSICAL ASSETS (INFRASTRUCTURE, BUILDINGS), HUMAN ASSETS (SKILLS, KNOWLEDGE), SOCIAL ASSETS (NETWORKS, RELATIONSHIPS), FINANCIAL ASSETS (SAVINGS, INVESTMENTS), AND NATURAL ASSETS (LAND, ENVIRONMENT).

### HOW CAN COMMUNITY DEVELOPMENT INITIATIVES PROMOTE ECONOMIC ASSET BUILDING?
