ASSESSMENT PROCESS AND METHODOLOGY

THE ASSESSMENT PROCESS FOR BC ASSESSMENTS 2023 INVOLVES A DETAILED ANALYSIS OF PROPERTY CHARACTERISTICS,

STEPS TO APPEAL AN ASSESSMENT

IF DISCREPANCIES OR ERRORS ARE IDENTIFIED, OWNERS CAN INITIATE AN APPEAL BY FOLLOWING THESE STEPS:

1. CONTACT BC ASSESSMENT FOR A REVIEW OR CLARIFICATION WITHIN THE DESIGNATED TIMEFRAME, USUALLY BY LATE JANUARY OR EARLY FEBRUARY.
2. IF UNRESOLVED, FILE A FORMAL NOTICE OF COMPLAINT WITH THE PROPERTY ASSESSMENT REVIEW PANEL (PARP) BY THE SPECIFIED DEADLINE.
3. PARTICIPATE IN HEARINGS WHERE EVIDENCE SUPPORTING THE APPEAL IS PRESENTED.
4. AWAIT THE PANEL'S DECISION, WHICH IS BINDING UNLESS FURTHER LEGAL ACTION IS PURSUED.

COMMON REASONS FOR APPEALS

TYPICAL GROUNDS FOR APPEALING BC ASSESSMENTS 2023 INCLUDE:

- INCORRECT PROPERTY DETAILS SUCH AS SIZE OR FEATURES
- MARKET VALUE OVERSTATED COMPARED TO SIMILAR PROPERTIES

THIS RATE VARIES BY JURISDICTION AND IS INFLUENCED BY FACTORS SUCH AS MUNICIPAL SERVICES, SCHOOL FUNDING REQUIREMENTS, AND INFRASTRUCTURE PROJECTS. THEREFORE, A HIGHER ASSESSED VALUE GENERALLY LEADS TO INCREASED PROPERTY TAXES UNLESS OFFSET BY RATE ADJUSTMENTS.
