CALIFORNIA A.B. 957 IS A SIGNIFICANT LEGISLATIVE BILL THAT ADDRESSES CRITICAL ISSUES WITHIN CALIFORNIA'S LEGAL AND REGULATORY FRAMEWORK. LEGISLATIVE BACKGROUND OF CALIFORNIA A.B. 957
