UNDERSTANDING THE CITY OF BEVERLY HILLS BUSINESS LICENSE

A BUSINESS LICENSE IN THE CITY OF BEVERLY HILLS IS A MANDATORY AUTHORIZATION THAT ALLOWS COMMERCIAL ACTIVITIES WITHIN THE CITY LIMITS. - COMPLETED RENEWAL APPLICATION FORM
- PROOF OF BUSINESS ADDRESS AND OWNERSHIP
- UPDATED INSURANCE CERTIFICATES (IF APPLICABLE)
- HEALTH PERMITS OR SAFETY CERTIFICATIONS (FOR REGULATED INDUSTRIES)
- TAX CLEARANCE OR PAYMENT CONFIRMATION

FEES AND PAYMENT METHODS

FEE STRUCTURE AND CALCULATION
