ONLINE AVAILABILITY

DIGITAL VERSIONS OF THE PAMPHLET ARE ACCESSIBLE ON THE CLARK COUNTY AUDITOR'S OFFICIAL WEBSITE. THESE DOWNLOADABLE FILES CAN BE VIEWED ON COMPUTERS, TABLETS, OR SMARTPHONES, MAKING IT EASY TO READ THE PAMPHLET ON THE GO. THE ONLINE VERSIONS ARE SEARCHABLE, FACILITATING QUICK ACCESS TO SPECIFIC INFORMATION.

PUBLIC LOCATIONS

VOTERS WHO DO NOT RECEIVE THE PAMPHLET BY MAIL CAN ACCESS IT ONLINE OR PICK UP A COPY AT DESIGNATED PUBLIC LOCATIONS. CONTACTING THE CLARK COUNTY AUDITOR'S OFFICE CAN RESOLVE MISSING PAMPHLET ISSUES.

CAN I TRUST THE INFORMATION IN THE PAMPHLET?

YES, THE PAMPHLET IS PREPARED BY ELECTION OFFICIALS AND INCLUDES VERIFIED INFORMATION. CANDIDATE STATEMENTS ARE SUBMITTED BY THE CANDIDATES THEMSELVES, WHILE BALLOT MEASURE SUMMARIES UNDERGO CAREFUL REVIEW TO MAINTAIN IMPARTIALITY.

IS THE PAMPHLET AVAILABLE IN OTHER LANGUAGES?

CLARK COUNTY PROVIDES TRANSLATED VERSIONS OF THE VOTERS PAMPHLET IN SEVERAL LANGUAGES TO SERVE THE COUNTY'S DIVERSE POPULATION. ADDITIONALLY, ACCESSIBLE FORMATS ARE AVAILABLE UPON REQUEST.
