HOW TO CALCULATE CLASS WIDTH

EXAMPLE CALCULATION

FOR INSTANCE, IF A DATASET HAS A MINIMUM VALUE OF 12 AND A MAXIMUM VALUE OF 98, AND THE ANALYST DECIDES TO USE 8 CLASSES, THE CLASS WIDTH WOULD BE:

$$(98 - 12) / 8 = 86 / 8 = 10.75$$

ROUNDING UP, THE CLASS WIDTH COULD BE SET TO 11, CREATING INTERVALS SUCH AS 12-22, 23-33, AND SO ON.

IMPORTANCE OF CLASS WIDTH IN DATA ANALYSIS
