MANNER.

ROLE OF CHILD SUPPORT AGENCIES

STATE AND LOCAL CHILD SUPPORT ENFORCEMENT AGENCIES PLAY A CRUCIAL ROLE IN MONITORING PAYMENTS AND ASSISTING CUSTODIAL PARENTS IN COLLECTION EFFORTS. THEY PROVIDE RESOURCES SUCH AS CASE TRACKING, MEDIATION, AND LEGAL ASSISTANCE. IN HIGH-PROFILE CASES LIKE THAT INVOLVING CORNEL WEST, AGENCIES MAY ALSO MANAGE PUBLIC COMMUNICATION TO MAINTAIN TRANSPARENCY.

IMPLICATIONS AND PUBLIC RESPONSE
