CANDIDATE STATEMENT GUIDELINES

TO MAINTAIN FAIRNESS AND CONSISTENCY, CANDIDATES SUBMIT THEIR STATEMENTS UNDER SPECIFIC GUIDELINES. THESE OFTEN INCLUDE WORD LIMITS AND REQUIREMENTS TO AVOID DEFAMATORY OR FALSE INFORMATION. THE ELECTIONS OFFICE REVIEWS SUBMISSIONS TO ENSURE COMPLIANCE WITH THESE RULES BEFORE INCLUDING THEM IN THE PAMPHLET.

EXAMPLES OF CANDIDATES IN 2022

IN THE 2022 PAMPHLET, VOTERS COULD EXPECT TO SEE CANDIDATES FOR A RANGE OF POSITIONS SUCH AS:

- DESCHUTES COUNTY BOARD OF COMMISSIONERS
- BEND CITY COUNCIL
- REDMOND SCHOOL DISTRICT BOARD
- VARIOUS SPECIAL DISTRICTS AND LOCAL OFFICES

BALLOT MEASURES AND EXPLANATIONS

ONE OF THE MOST CRITICAL SECTIONS OF THE DESCHUTES COUNTY VOTERS' PAMPHLET 2022 IS THE PRESENTATION OF BALLOT MEASURES. THESE MEASURES CAN INCLUDE BOND PROPOSALS, TAX LEVIES, AMENDMENTS TO LOCAL CHARTERS, AND STATE LEGISLATIVE REFERRALS. EACH MEASURE IS EXPLAINED IN CLEAR LANGUAGE, OUTLINING ITS PURPOSE, THE EXPECTED IMPACT, AND FISCAL CONSIDERATIONS.

FISCAL IMPACT STATEMENTS

HOW TO ACCESS AND USE THE VOTERS' PAMPHLET

THE DESCHUTES COUNTY VOTERS' PAMPHLET 2022 IS MADE AVAILABLE TO ALL REGISTERED VOTERS FREE OF CHARGE. IT CAN BE ACCESSED IN SEVERAL WAYS TO ACCOMMODATE DIVERSE VOTER PREFERENCES AND NEEDS.

DISTRIBUTION METHODS

- DOWNLOADABLE DIGITAL VERSIONS ON OFFICIAL DESCHUTES COUNTY WEBSITES

3. REVIEWING FISCAL IMPACT STATEMENTS FOR INFORMED FINANCIAL CONSIDERATIONS
4. NOTING IMPORTANT VOTING DATES AND DEADLINES INCLUDED IN THE PAMPHLET
5. USING THE PAMPHLET AS A REFERENCE WHILE COMPLETING MAIL-IN OR IN-PERSON BALLOTS

VOTING PROCEDURES AND IMPORTANT DATES IN DESCHUTES COUNTY

THE DESCHUTES COUNTY VOTERS' PAMPHLET 2022 ALSO INCLUDES DETAILED INSTRUCTIONS ON VOTING PROCEDURES, ENSURING VOTERS KNOW HOW TO PARTICIPATE CORRECTLY AND AVOID COMMON ERRORS THAT CAN INVALIDATE BALLOTS. VOTING BY MAIL

IN-PERSON VOTING AND ASSISTANCE

IT ALSO DESCRIBES ACCOMMODATIONS AVAILABLE FOR VOTERS WITH DISABILITIES OR THOSE NEEDING LANGUAGE ASSISTANCE.
