UNDERSTANDING GOLF RULES AND CHEATING

TO PROPERLY ASSESS THE QUESTION, DID BROOKS KOEPKA CHEAT, IT IS ESSENTIAL TO FIRST UNDERSTAND THE RULES OF GOLF AND WHAT CONSTITUTES CHEATING IN THE SPORT. - IMPROPERLY MARKING OR MOVING THE BALL
- USING NON-CONFORMING EQUIPMENT
- FAILING TO COUNT PENALTY STROKES
- ALTERING THE PLAYING CONDITIONS
- DELIBERATE RULE INFRACTIONS DURING PLAY

GOLF IS UNIQUE IN THAT PLAYERS ARE EXPECTED TO SELF-REPORT ANY RULES VIOLATIONS, PLACING A HIGH VALUE ON HONESTY AND SPORTSMANSHIP.

THE IMPORTANCE OF INTEGRITY IN GOLF

INTEGRITY IS A CORNERSTONE OF GOLF'S CULTURE. MOST PROFESSIONAL PLAYERS ADHERE STRICTLY TO THE RULES, AND INCIDENTS OF CHEATING ARE RELATIVELY RARE AND OFTEN MET WITH SWIFT PENALTIES. UNDERSTANDING THIS CONTEXT HELPS FRAME THE DISCUSSION AROUND ANY CHEATING ALLEGATIONS AGAINST BROOKS KOEPKA.

BROOKS KOEPKA'S CAREER AND REPUTATION
