UNDERSTANDING EARLY VOTING IN SUMMIT COUNTY

EARLY VOTING IN SUMMIT COUNTY ALLOWS REGISTERED VOTERS TO CAST THEIR BALLOTS BEFORE THE OFFICIAL ELECTION DAY, PROVIDING GREATER FLEXIBILITY AND CONVENIENCE. THIS PROCESS IS DESIGNED TO INCREASE VOTER PARTICIPATION BY OFFERING MULTIPLE OPPORTUNITIES TO VOTE IN PERSON AT DESIGNATED LOCATIONS. EARLY VOTING IS PARTICULARLY BENEFICIAL IN MITIGATING ELECTION DAY CONGESTION AND ACCOMMODATING VOTERS WHO MAY HAVE SCHEDULING CONFLICTS. SUMMIT COUNTY'S EARLY VOTING PROGRAM FOLLOWS STATE GUIDELINES AND ENSURES THAT VOTES ARE SECURELY COLLECTED AND TABULATED. FOR SUMMIT COUNTY, EARLY VOTING SUPPORTS DEMOCRATIC ENGAGEMENT BY PROVIDING A RELIABLE AND SECURE METHOD FOR CASTING BALLOTS AHEAD OF TIME.

LEGAL FRAMEWORK GOVERNING EARLY VOTING

OPERATING HOURS DURING EARLY VOTING PERIOD

EARLY VOTING HOURS IN SUMMIT COUNTY GENERALLY INCLUDE:

- WEEKDAYS: 8:00 AM TO 5:00 PM
- EXTENDED HOURS: SOME LOCATIONS MAY OFFER EVENING HOURS UNTIL 7:00 PM OR 8:00 PM
- WEEKEND HOURS: SELECT SITES OPEN ON SATURDAYS AND SUNDAYS DURING EARLY VOTING WEEKS

IT IS RECOMMENDED THAT VOTERS CHECK THE LATEST SCHEDULE RELEASED BY THE SUMMIT COUNTY BOARD OF ELECTIONS, AS HOURS MAY VARY DEPENDING ON THE ELECTION TYPE AND LOCATION.

ELIGIBILITY AND REGISTRATION REQUIREMENTS

TO PARTICIPATE IN EARLY VOTING IN SUMMIT COUNTY, INDIVIDUALS MUST MEET SPECIFIC ELIGIBILITY CRITERIA AND BE PROPERLY REGISTERED TO VOTE. THESE REQUIREMENTS ENSURE THAT ONLY QUALIFIED VOTERS CAN CAST BALLOTS AND THAT THE ELECTION PROCESS REMAINS SECURE AND ORDERLY.

VOTER ELIGIBILITY CRITERIA

ELIGIBLE VOTERS IN SUMMIT COUNTY MUST:

- BE A UNITED STATES CITIZEN

- BE AT LEAST 18 YEARS OLD ON OR BEFORE THE ELECTION DAY
- NOT BE DISENFRANCHISED DUE TO FELONY CONVICTIONS OR LEGAL INCAPACITY

MEETING THESE CRITERIA IS ESSENTIAL FOR PARTICIPATION IN EARLY VOTING.

REGISTRATION PROCESS AND DEADLINES

VOTERS MUST BE REGISTERED BEFORE THEY ARE ELIGIBLE TO VOTE EARLY. SUMMIT COUNTY OFFERS MULTIPLE OPTIONS FOR VOTER REGISTRATION, INCLUDING ONLINE REGISTRATION, MAIL-IN FORMS, AND IN-PERSON REGISTRATION AT THE BOARD OF ELECTIONS OR OTHER DESIGNATED LOCATIONS. REGISTRATION DEADLINES VARY BY ELECTION BUT TYPICALLY CLOSE 30 DAYS BEFORE THE ELECTION DATE. ADDITIONALLY, OHIO ALLOWS SAME-DAY REGISTRATION DURING EARLY VOTING PERIODS AT DESIGNATED SITES, ENABLING UNREGISTERED VOTERS TO REGISTER AND VOTE ON THE SPOT.

BENEFITS OF EARLY VOTING IN SUMMIT COUNTY

EARLY VOTING PROVIDES NUMEROUS ADVANTAGES FOR BOTH VOTERS AND ELECTION ADMINISTRATORS, CONTRIBUTING TO A MORE EFFICIENT AND ACCESSIBLE ELECTORAL PROCESS IN SUMMIT COUNTY.

CONVENIENCE AND FLEXIBILITY

INCREASED VOTER PARTICIPATION

STUDIES SHOW THAT EARLY VOTING TENDS TO INCREASE OVERALL VOTER TURNOUT BY REMOVING BARRIERS SUCH AS SCHEDULING CONFLICTS AND WAIT TIMES. SUMMIT COUNTY'S COMMITMENT TO EARLY VOTING REFLECTS A BROADER GOAL TO PROMOTE CIVIC ENGAGEMENT AND DEMOCRATIC PARTICIPATION.

REDUCED ELECTION DAY CONGESTION

DISTRIBUTING VOTER TURNOUT OVER AN EXTENDED PERIOD ALLEVIATES PRESSURE ON POLLING LOCATIONS AND ELECTION WORKERS ON ELECTION DAY. THIS LEADS TO FASTER PROCESSING TIMES, FEWER ERRORS, AND IMPROVED VOTER SATISFACTION.

ENHANCED PUBLIC HEALTH AND SAFETY

ESPECIALLY RELEVANT DURING PUBLIC HEALTH CONCERNS, EARLY VOTING LIMITS THE NUMBER OF VOTERS GATHERING AT POLLING PLACES SIMULTANEOUSLY, HELPING TO MAINTAIN SOCIAL DISTANCING AND REDUCE THE SPREAD OF ILLNESS.

HOW TO CAST YOUR BALLOT DURING EARLY VOTING

PARTICIPATING IN EARLY VOTING IN SUMMIT COUNTY INVOLVES SEVERAL STRAIGHTFORWARD STEPS DESIGNED TO ENSURE A SECURE AND ACCURATE VOTE.

IDENTIFYING EARLY VOTING LOCATIONS

REQUIRED IDENTIFICATION AND DOCUMENTATION

OHIO LAW REQUIRES VOTERS TO PRESENT VALID IDENTIFICATION WHEN VOTING IN PERSON. ACCEPTABLE FORMS INCLUDE:

- OHIO DRIVER'S LICENSE OR STATE ID CARD
- U.S. PASSPORT
- MILITARY ID
- CURRENT UTILITY BILL, BANK STATEMENT, PAYCHECK, OR GOVERNMENT DOCUMENT SHOWING THE VOTER'S NAME AND ADDRESS

VOTERS SHOULD BRING ONE FORM OF ID TO ENSURE A SEAMLESS CHECK-IN PROCESS.

VOTING PROCEDURE AT EARLY VOTING SITES

AFTER VERIFYING IDENTIFICATION AND REGISTRATION STATUS, VOTERS RECEIVE A BALLOT AND INSTRUCTIONS FROM ELECTION OFFICIALS. VOTERS MARK THEIR CHOICES IN PRIVACY, THEN SUBMIT THEIR BALLOTS ACCORDING TO THE SITE'S PROCEDURES. ELECTION STAFF ARE AVAILABLE TO ASSIST WITH ANY QUESTIONS OR ACCOMMODATIONS NEEDED.

COMMON QUESTIONS ABOUT EARLY VOTING

MANY VOTERS HAVE QUESTIONS REGARDING THE EARLY VOTING PROCESS IN SUMMIT COUNTY. ADDRESSING THESE CONCERNS HELPS PROMOTE CONFIDENCE AND PARTICIPATION.

CAN I CHANGE MY VOTE AFTER VOTING EARLY?

ONCE A BALLOT IS CAST DURING EARLY VOTING, IT CANNOT BE CHANGED OR REVOKED. VOTERS SHOULD ENSURE THEIR SELECTIONS ARE FINAL BEFORE SUBMITTING THEIR BALLOT.

IS EARLY VOTING AVAILABLE FOR ALL ELECTIONS?

EARLY VOTING IS GENERALLY AVAILABLE FOR PRIMARY, GENERAL, AND SPECIAL ELECTIONS. HOWEVER, AVAILABILITY AND SPECIFIC PROCEDURES MAY VARY DEPENDING ON THE ELECTION TYPE, SO CHECKING CURRENT INFORMATION IS ADVISABLE.

WHAT HAPPENS IF I VOTE EARLY AND THEN VOTE AGAIN ON ELECTION DAY?

OHIO LAW PERMITS VOTERS TO UPDATE THEIR VOTE BY CASTING A NEW BALLOT ON ELECTION DAY, WHICH WILL SUPERSEDE THE EARLY VOTE. HOWEVER, VOTERS MUST GO TO THEIR ASSIGNED PRECINCT POLLING PLACE ON ELECTION DAY TO DO SO.

ARE MAIL-IN AND EARLY VOTING THE SAME?

NO, EARLY VOTING REFERS TO IN-PERSON VOTING BEFORE ELECTION DAY, WHILE MAIL-IN VOTING INVOLVES SUBMITTING A BALLOT BY MAIL. BOTH SERVE TO INCREASE VOTING ACCESSIBILITY BUT FOLLOW DIFFERENT PROCEDURES.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE EARLY VOTING DATES FOR SUMMIT COUNTY?
