VERIFICATION PROCESS OVERVIEW

POOR QUALITY OR UNACCEPTABLE DOCUMENTS

SUBMITTING DOCUMENTS THAT ARE BLURRY, EXPIRED, OR NOT OFFICIALLY RECOGNIZED CAN RESULT IN FAILED VERIFICATION. PRIZEPICKS REQUIRES CLEAR, VALID, AND CURRENT GOVERNMENT-ISSUED IDENTIFICATION DOCUMENTS. PHOTOS OF DOCUMENTS MUST BE LEGIBLE AND INCLUDE ALL RELEVANT DETAILS WITHOUT ANY OBSTRUCTIONS.

TECHNICAL ISSUES AND SYSTEM ERRORS

SOMETIMES, FAILED VERIFICATION IS CAUSED BY TECHNICAL GLITCHES ON THE PRIZEPICKS PLATFORM OR ISSUES WITH THIRD-PARTY VERIFICATION SERVICES. THESE ERRORS MAY REQUIRE USERS TO RETRY THE SUBMISSION OR CONTACT CUSTOMER SUPPORT FOR ASSISTANCE.

DISCREPANCIES BETWEEN DOCUMENTS AND ACCOUNT INFORMATION

REQUIRED DOCUMENTS AND INFORMATION FOR VERIFICATION

TO SUCCESSFULLY VERIFY IDENTITY ON PRIZEPICKS, USERS MUST PROVIDE SPECIFIC DOCUMENTS AND PERSONAL INFORMATION THAT MEET THE PLATFORM'S STANDARDS. KNOWING WHAT IS REQUIRED AHEAD OF TIME CAN REDUCE THE CHANCES OF FAILED VERIFICATION.

- PASSPORT
- STATE-ISSUED IDENTIFICATION CARD

THESE DOCUMENTS MUST BE CURRENT AND VALID, WITH NO VISIBLE DAMAGE OR ALTERATIONS.

PROOF OF ADDRESS DOCUMENTS

IN SOME CASES, PRIZEPICKS MAY REQUIRE PROOF OF ADDRESS TO VERIFY A USER'S RESIDENCY. ACCEPTABLE DOCUMENTS FOR THIS PURPOSE INCLUDE:

- UTILITY BILLS (ELECTRICITY, WATER, GAS)

THESE DOCUMENTS SHOULD BE RECENT, TYPICALLY DATED WITHIN THE LAST THREE MONTHS.

PERSONAL INFORMATION REQUIREMENTS

USERS MUST PROVIDE ACCURATE PERSONAL DETAILS THAT INCLUDE FULL LEGAL NAME, DATE OF BIRTH, AND CURRENT RESIDENTIAL ADDRESS. THIS INFORMATION MUST MATCH THE SUBMITTED DOCUMENTS EXACTLY TO AVOID VERIFICATION ISSUES.

VERIFYING THAT THE PERSONAL INFORMATION ENTERED DURING REGISTRATION MATCHES EXACTLY WITH THE ID AND PROOF OF ADDRESS DOCUMENTS IS CRUCIAL. IF DISCREPANCIES EXIST, USERS MAY NEED TO UPDATE THEIR PROFILE DETAILS BEFORE RESUBMITTING DOCUMENTS.

CONTACT PRIZEPICKS CUSTOMER SUPPORT

READ AND FOLLOW ANY SPECIFIC INSTRUCTIONS PROVIDED BY PRIZEPICKS REGARDING THE VERIFICATION PROCESS. THIS INCLUDES FORMAT, FILE SIZE, AND DOCUMENT SUBMISSION METHODS.

- USE CLEAR, WELL-LIT PHOTOS OR SCANS
- MATCH ALL PERSONAL INFORMATION EXACTLY
- SUBMIT VALID, UNEXPIRED GOVERNMENT-ISSUED IDs
- PROVIDE RECENT PROOF OF ADDRESS IF REQUESTED
- CONTACT SUPPORT IF ISSUES PERSIST

FREQUENTLY ASKED QUESTIONS

HOW CAN I FIX THE 'FAILED TO VERIFY IDENTITY' ERROR ON PRIZEPICKS?

ENSURE YOU UPLOAD CLEAR, VALID IDENTIFICATION DOCUMENTS THAT MATCH YOUR ACCOUNT DETAILS, AND TRY SUBMITTING THEM AGAIN. CONTACT PRIZEPICKS SUPPORT IF THE ISSUE PERSISTS.
