SWITCHING COSTS MOAT

HIGH SWITCHING COSTS OCCUR WHEN CUSTOMERS FACE SIGNIFICANT INCONVENIENCE OR EXPENSE TO CHANGE PROVIDERS, WHICH DISCOURAGES DEFECTION TO COMPETITORS.

INTANGIBLE ASSETS MOAT

THIS INCLUDES PROPRIETARY TECHNOLOGY, PATENTS, TRADEMARKS, AND OTHER INTELLECTUAL PROPERTY THAT PROVIDE EXCLUSIVE ADVANTAGES IN THE MARKETPLACE.
