

FLORIDA BILL SB 1718

FLORIDA BILL SB 1718 IS A SIGNIFICANT PIECE OF LEGISLATION INTRODUCED IN THE FLORIDA SENATE THAT ADDRESSES CRITICAL ASPECTS OF POLICY AFFECTING THE STATE'S GOVERNANCE AND REGULATORY FRAMEWORK. OVERVIEW AND BACKGROUND OF FLORIDA BILL SB 1718

FLORIDA BILL SB 1718 WAS INTRODUCED AS PART OF THE STATE'S LEGISLATIVE EFFORTS TO ADDRESS EMERGING ISSUES AND IMPROVE REGULATORY FRAMEWORKS IN VARIOUS DOMAINS.
