2. DIVIDE THAT NUMBER BY THE TOTAL ARTICLES PUBLISHED IN 2021 AND 2022.

THIS CALCULATION YIELDS THE IMPACT FACTOR FOR 2023, WHICH IS PUBLISHED ANNUALLY.

SIGNIFICANCE AND LIMITATIONS

WHILE THE FRONTIERS CARDIOVASCULAR MEDICINE IMPACT FACTOR SERVES AS A CONVENIENT METRIC TO GAUGE JOURNAL INFLUENCE, IT HAS LIMITATIONS.
