REQUESTING MEDICAL RECORDS AT GOOD SAMARITAN HOSPITAL LOS ANGELES

HOW TO SUBMIT A MEDICAL RECORDS REQUEST

- SPECIFYING THE DATES AND TYPES OF RECORDS NEEDED
- SUBMITTING THE REQUEST TO THE HOSPITAL'S HIM DEPARTMENT

PROCESSING TIME AND FEES

GOOD SAMARITAN HOSPITAL LOS ANGELES STRIVES TO PROCESS REQUESTS PROMPTLY, GENERALLY WITHIN 30 DAYS AS MANDATED BY LAW. HOWEVER, THE EXACT TIMEFRAME MAY VARY DEPENDING ON THE VOLUME OF REQUESTS AND NATURE OF THE RECORDS. PATIENTS MAY BE CHARGED REASONABLE FEES FOR COPYING, MAILING, OR ELECTRONIC DELIVERY OF RECORDS, CONSISTENT WITH STATE AND FEDERAL GUIDELINES.

PRIVACY AND SECURITY OF MEDICAL RECORDS

PROTECTING PATIENT PRIVACY IS A FUNDAMENTAL PRIORITY AT GOOD SAMARITAN HOSPITAL LOS ANGELES. DATA SECURITY MEASURES

THE HOSPITAL EMPLOYS MULTIPLE LAYERS OF SECURITY, INCLUDING ELECTRONIC HEALTH RECORD (EHR) SYSTEMS WITH ENCRYPTION, ACCESS CONTROLS, AND AUDIT TRAILS. 1. MAIL DELIVERY TO THE PATIENT'S OR AUTHORIZED RECIPIENT'S ADDRESS
2. IN-PERSON PICKUP AT THE HOSPITAL'S HEALTH INFORMATION MANAGEMENT OFFICE
3. SECURE ELECTRONIC DELIVERY THROUGH PATIENT PORTALS OR ENCRYPTED EMAIL

LEGAL AND COMPLIANCE CONSIDERATIONS

HANDLING MEDICAL RECORDS AT GOOD SAMARITAN HOSPITAL LOS ANGELES INVOLVES COMPLIANCE WITH A VARIETY OF LAWS AND REGULATIONS TO PROTECT PATIENT RIGHTS AND ENSURE LAWFUL MANAGEMENT OF HEALTH INFORMATION. ARE THERE ANY COSTS ASSOCIATED WITH OBTAINING RECORDS?

YES. REASONABLE FEES MAY APPLY FOR COPYING, MAILING, OR ELECTRONIC DELIVERY OF RECORDS. THESE FEES COMPLY WITH

STATE AND FEDERAL REGULATIONS AND ARE COMMUNICATED TO THE REQUESTER IN ADVANCE.

CAN RECORDS BE SHARED ELECTRONICALLY?
