AS CHUNKS ARE DOWNLOADED, THE USER SIMULTANEOUSLY UPLOADS THOSE PIECES TO OTHER PEERS, CREATING A NETWORK OF SHARED RESOURCES. THIS METHOD OPTIMIZES BANDWIDTH USAGE AND ACCELERATES DOWNLOAD SPEEDS.

TORRENT CLIENTS AND TRACKERS

TO ENGAGE IN TORRENTING, USERS NEED A TORRENT CLIENT—A SOFTWARE APPLICATION THAT MANAGES DOWNLOADING AND UPLOADING. POPULAR CLIENTS INCLUDE UTORRENT, BITTORRENT, AND QBITORRENT. TRACKERS ARE SERVERS THAT HELP COORDINATE COMMUNICATION BETWEEN PEERS AND FACILITATE EFFICIENT DATA EXCHANGE. MAGNET LINKS OR .TORRENT FILES PROVIDE THE NECESSARY METADATA FOR THESE CLIENTS TO CONNECT TO THE APPROPRIATE TRACKER AND PEERS.

RISKS ASSOCIATED WITH GROUNDHOG DAY TORRENT
