IF THE SPEECH IS ACCESSED THROUGH A BOOK OR WEBSITE, ADDITIONAL PUBLICATION INFORMATION IS INCLUDED. MLA EMPHASIZES THE IMPORTANCE OF THE ORIGINAL DELIVERY DATE AND LOCATION.

APA CITATION FORMAT

APA STYLE REQUIRES THE SPEAKER’S NAME, THE YEAR OF THE SPEECH, THE TITLE (IF AVAILABLE), AND DETAILS ABOUT THE EVENT. AN EXAMPLE CITATION MIGHT BE:

- KING, M. L., JR. (1963, AUGUST 28). I HAVE A DREAM [SPEECH TRANSCRIPT]. MARCH ON WASHINGTON FOR JOBS AND FREEDOM, WASHINGTON, D.C.

WHEN CITING A RECORDED VERSION, THE FORMAT CAN INCLUDE RETRIEVAL INFORMATION OR DOI IF APPLICABLE. APA FOCUSES ON PROVIDING ENOUGH DETAIL FOR READERS TO LOCATE THE ORIGINAL SPEECH.

CHICAGO MANUAL OF STYLE
