OVERVIEW OF INDIANA MEDICAID HOME HEALTH REIMBURSEMENT RATES

INDIANA MEDICAID HOME HEALTH REIMBURSEMENT RATES ARE ESTABLISHED TO COMPENSATE HOME HEALTH AGENCIES FOR PROVIDING MEDICALLY NECESSARY SERVICES TO ELIGIBLE MEDICAID RECIPIENTS IN THEIR HOMES. THESE RATES COVER A RANGE OF SERVICES, INCLUDING SKILLED NURSING CARE, PHYSICAL THERAPY, OCCUPATIONAL THERAPY, SPEECH THERAPY, AND HOME HEALTH AIDE SERVICES. THE REIMBURSEMENT RATES ARE DETERMINED BY THE INDIANA FAMILY AND SOCIAL SERVICES ADMINISTRATION (FSSA) AND ARE DESIGNED TO ALIGN WITH BOTH STATE BUDGETARY CONSTRAINTS AND FEDERAL MEDICAID REQUIREMENTS.

REIMBURSEMENT RATES IN INDIANA ARE TYPICALLY BASED ON A FEE-FOR-SERVICE MODEL, WHERE PROVIDERS SUBMIT CLAIMS FOR ELIGIBLE SERVICES AND RECEIVE PAYMENT ACCORDING TO PREDETERMINED FEE SCHEDULES. FACTORS INFLUENCING REIMBURSEMENT RATES

CLAIM SUBMISSION PROCESS

HOME HEALTH PROVIDERS SUBMIT CLAIMS ELECTRONICALLY THROUGH THE INDIANA MEDICAID MANAGEMENT INFORMATION SYSTEM (MMIS). EACH CLAIM MUST INCLUDE DETAILED DOCUMENTATION OF SERVICES RENDERED, INCLUDING DATES, SERVICE CODES, PROVIDER CREDENTIALS, AND PATIENT INFORMATION. PROPER CODING ACCORDING TO CURRENT PROCEDURAL

TERMINOLOGY (CPT) AND HEALTHCARE COMMON PROCEDURE CODING SYSTEM (HCPCS) STANDARDS IS MANDATORY.

DOCUMENTATION AND COMPLIANCE REQUIREMENTS

INDIANA MEDICAID REQUIRES COMPREHENSIVE DOCUMENTATION TO SUPPORT CLAIMS, INCLUDING PHYSICIAN ORDERS, CARE PLANS, AND PROGRESS NOTES. COMPLIANCE WITH DOCUMENTATION STANDARDS ENSURES THAT SERVICES ARE MEDICALLY NECESSARY AND MEET MEDICAID COVERAGE CRITERIA.

PAYMENT TIMELINES
