OVERVIEW AND HISTORY OF THE JAMES MADISON PROGRAM

THE JAMES MADISON PROGRAM PRINCETON WAS FOUNDED TO PROMOTE SCHOLARLY INQUIRY INTO THE PRINCIPLES OF CONSTITUTIONAL GOVERNMENT AND THE RULE OF LAW. ESTABLISHED IN 2000, THE PROGRAM HONORS JAMES MADISON, THE FOURTH PRESIDENT OF THE UNITED STATES AND A PRINCIPAL ARCHITECT OF THE U.S. CONSTITUTION. IT SERVES AS A HUB FOR INTERDISCIPLINARY RESEARCH, CONNECTING POLITICAL SCIENCE, LAW, HISTORY, AND PHILOSOPHY. OVER THE YEARS, THE PROGRAM HAS GROWN TO BECOME A LEADING CENTER FOR THE STUDY OF AMERICAN CONSTITUTIONALISM, ATTRACTING RENOWNED SCHOLARS AND STUDENTS WORLDWIDE.

- FACILITATE PUBLIC UNDERSTANDING OF CONSTITUTIONAL ISSUES THROUGH LECTURES AND PUBLICATIONS.

COMMITMENT TO INTELLECTUAL DIVERSITY

THE PROGRAM EMPHASIZES A BROAD SPECTRUM OF VIEWPOINTS, ENCOURAGING DIALOGUE ACROSS DIFFERENT SCHOOLS OF THOUGHT. THIS COMMITMENT ENSURES THAT THE JAMES MADISON PROGRAM PRINCETON REMAINS A VIBRANT FORUM FOR SCHOLARSHIP AND DISCUSSION ON FUNDAMENTAL POLITICAL AND LEGAL QUESTIONS.
