SPECIAL COLLECTION SCHEDULES

IN ADDITION TO WEEKLY GARBAGE PICKUP, LEHIGH ACRES OFFERS SCHEDULED COLLECTIONS FOR RECYCLABLES, YARD WASTE, AND BULK ITEMS. ACCEPTED WASTE TYPES AND PROPER DISPOSAL

PLACEMENT AND TIMING
