NO, THE MDTA WAS EVENTUALLY REPLACED OR SUPERSEDED BY OTHER WORKFORCE DEVELOPMENT LEGISLATION SUCH AS THE COMPREHENSIVE EMPLOYMENT AND TRAINING ACT (CETA) AND LATER THE WORKFORCE INVESTMENT ACT (WIA), WHICH MODERNIZED AND EXPANDED FEDERAL JOB TRAINING PROGRAMS.

WHAT TYPES OF TRAINING PROGRAMS WERE FUNDED UNDER THE MANPOWER DEVELOPMENT AND TRAINING ACT?

THE ACT FUNDED A VARIETY OF TRAINING PROGRAMS INCLUDING VOCATIONAL EDUCATION, TECHNICAL SKILLS TRAINING, APPRENTICESHIPS, AND JOB PLACEMENT SERVICES AIMED AT EQUIPPING WORKERS WITH SKILLS IN EMERGING INDUSTRIES AND TECHNOLOGIES.
