EACH CATEGORY IS DOCUMENTED THOROUGHLY TO CAPTURE RELEVANT DETAILS FOR ANALYSIS.

COMMON MISHAP CATEGORIES

- VEHICLE AND TRANSPORTATION ACCIDENTS
- AIRCRAFT AND AVIATION INCIDENTS
- TRAINING ACCIDENTS
- OCCUPATIONAL AND INDUSTRIAL MISHAPS
- ENVIRONMENTAL AND WEATHER-RELATED INCIDENTS
