DEPERSONALIZATION

DEPERSONALIZATION MEASURES AN IMPERSONAL RESPONSE TOWARD PATIENTS AND COLLEAGUES, OFTEN MANIFESTING AS CYNICISM OR DETACHMENT. ELEVATED DEPERSONALIZATION SCORES HIGHLIGHT A COPING MECHANISM THAT CAN IMPAIR EMPATHY AND PATIENT INTERACTION.

PERSONAL ACCOMPLISHMENT

THIS SUBSCALE ASSESSES FEELINGS OF COMPETENCE AND ACHIEVEMENT AT WORK. LOWER SCORES SUGGEST A REDUCED SENSE OF EFFICACY AND ACCOMPLISHMENT, CONTRIBUTING TO THE OVERALL BURNOUT EXPERIENCE.

TYPICAL FORMAT AND SCORING

THE INVENTORY INCLUDES 22 ITEMS WITH RESPONSES RANGING FROM "NEVER" TO "EVERY DAY." SCORES ARE CALCULATED FOR EACH SUBSCALE, AND PATTERNS ACROSS THESE SCALES HELP IDENTIFY BURNOUT LEVELS. INTERPRETATION GUIDELINES CATEGORIZE RESULTS AS LOW, MODERATE, OR HIGH BURNOUT RISK.
