FAMILIES, SINGLE ADULTS, AND SMALL BUSINESS EMPLOYEES IN WORCESTER CAN ALL FIND SUITABLE COVERAGE OPTIONS THROUGH THIS SYSTEM.

ENROLLMENT PERIODS AND SPECIAL ENROLLMENT

THE MASS HEALTH CONNECTOR WORCESTER OPERATES UNDER DESIGNATED OPEN ENROLLMENT PERIODS, TYPICALLY OCCURRING ANNUALLY, DURING WHICH RESIDENTS CAN SIGN UP FOR OR CHANGE HEALTH PLANS. OUTSIDE OF THIS TIMEFRAME, SPECIAL ENROLLMENT PERIODS ARE AVAILABLE FOR QUALIFYING LIFE EVENTS SUCH AS MARRIAGE, BIRTH OF A CHILD, LOSS OF OTHER COVERAGE, OR RELOCATION. THESE PROVISIONS ENSURE THAT WORCESTER RESIDENTS CAN OBTAIN NECESSARY COVERAGE EVEN OUTSIDE REGULAR ENROLLMENT WINDOWS.

STEPS TO ENROLL

TYPES OF PLANS OFFERED

- **CATASTROPHIC PLANS:** DESIGNED FOR YOUNG ADULTS AND THOSE WITH HARDSHIP EXEMPTIONS, OFFERING LOW PREMIUMS BUT HIGH DEDUCTIBLES.

COVERAGE AND BENEFITS

ALL PLANS AVAILABLE VIA THE MASS HEALTH CONNECTOR WORCESTER COMPLY WITH MASSACHUSETTS AND FEDERAL REGULATIONS, ENSURING COVERAGE OF ESSENTIAL HEALTH BENEFITS SUCH AS PREVENTIVE CARE, HOSPITALIZATION, PRESCRIPTION DRUGS, MENTAL HEALTH SERVICES, AND MATERNITY CARE. HOW TO APPLY FOR FINANCIAL HELP

WHAT IS MASSHEALTH?

MASSHEALTH OFFERS FREE OR LOW-COST HEALTH INSURANCE FOR ELIGIBLE RESIDENTS, INCLUDING CHILDREN, PREGNANT WOMEN, SENIORS, DISABLED INDIVIDUALS, AND LOW-INCOME ADULTS. THE PROGRAM COVERS A WIDE ARRAY OF MEDICAL SERVICES AND OFTEN REQUIRES LITTLE TO NO PREMIUM PAYMENTS.

APPLYING FOR MASSHEALTH THROUGH THE CONNECTOR

THE MASS HEALTH CONNECTOR WORCESTER PLATFORM ALLOWS APPLICANTS TO APPLY FOR MASSHEALTH SIMULTANEOUSLY WHILE EXPLORING OTHER INSURANCE OPTIONS. THIS INTEGRATION STREAMLINES THE PROCESS AND HELPS RESIDENTS QUICKLY IDENTIFY THE BEST COVERAGE BASED ON INCOME AND HOUSEHOLD INFORMATION.

OTHER PUBLIC ASSISTANCE PROGRAMS

REPORTING CHANGES
