- MEET PHYSICAL FITNESS STANDARDS AS REQUIRED BY THE HIRING AGENCY.

APPLICATION PROCEDURES

SUBMITTING AN APPLICATION FOR THE MASSACHUSETTS POLICE EXAM 2022 GENERALLY INVOLVES COMPLETING AN ONLINE REGISTRATION THROUGH THE OFFICIAL MASSACHUSETTS HUMAN RESOURCES DIVISION PORTAL OR THROUGH LOCAL POLICE DEPARTMENT RECRUITMENT PAGES. EXAM CONTENT AND FORMAT

5. **MEMORY AND OBSERVATION:** TESTS MAY INCLUDE EXERCISES DESIGNED TO ASSESS ATTENTION TO DETAIL AND RECALL ABILITY, IMPORTANT FOR EVIDENCE GATHERING AND WITNESS STATEMENTS.

EXAM DURATION AND SCORING

THE TOTAL DURATION OF THE MASSACHUSETTS POLICE EXAM 2022 VARIES BY ADMINISTERING AGENCY BUT GENERALLY RANGES BETWEEN TWO TO THREE HOURS. SCORING AND POST-EXAM PROCEDURES
