- USE PATIENT PORTALS AND RECORD ACCESS RESPONSIBLY AND SECURELY.
- RESPECT MULTICARE'S POLICIES REGARDING MEDICAL RECORDS AND PRIVACY.

HOW LONG DOES IT TAKE TO RECEIVE MEDICAL RECORDS FROM MULTICARE HEALTH SYSTEM AFTER A REQUEST?
