TRAINING AND COMMUNICATION

PROGRAM EVALUATION AND CONTINUOUS IMPROVEMENT

STRONG LEADERSHIP COMMITMENT IS VITAL FOR THE SUCCESS OF ANY SAFETY PROGRAM. MANAGEMENT SHOULD DEMONSTRATE SUPPORT THROUGH RESOURCE ALLOCATION, POLICY ENFORCEMENT, AND ACTIVE INVOLVEMENT IN SAFETY INITIATIVES.

CONTINUOUS IMPROVEMENT

USE DATA COLLECTED FROM INSPECTIONS, INCIDENT INVESTIGATIONS, AND EMPLOYEE FEEDBACK TO REFINE THE SAFETY PROGRAM. CONTINUOUS IMPROVEMENT ENSURES THE PROGRAM EVOLVES WITH CHANGING WORKPLACE CONDITIONS AND REGULATORY REQUIREMENTS.
