DEFINITION AND PURPOSE OF PRACTICE AGREEMENTS

IMPLICATIONS FOR CREDENTIALING AND LICENSING

IN STATES WITH REDUCED OR RESTRICTED PRACTICE, NURSE PRACTITIONERS MUST ENTER INTO WRITTEN PRACTICE AGREEMENTS THAT SPECIFY THE EXTENT OF PHYSICIAN SUPERVISION OR COLLABORATION. THESE AGREEMENTS MAY LIMIT PRESCRIPTIVE AUTHORITY OR REQUIRE DIRECT OVERSIGHT OF CERTAIN CLINICAL ACTIVITIES.

EXAMPLES OF STATE-SPECIFIC REQUIREMENTS

- CALIFORNIA MANDATES STANDARDIZED PROTOCOLS FOR NURSE PRACTITIONERS IN COLLABORATION WITH PHYSICIANS.

WHEN WELL-STRUCTURED, PRACTICE AGREEMENTS PROMOTE COLLABORATION, IMPROVE COMMUNICATION, AND ENHANCE PATIENT OUTCOMES BY LEVERAGING THE EXPERTISE OF BOTH NURSE PRACTITIONERS AND PHYSICIANS. THEY PROVIDE A FRAMEWORK FOR SHARED RESPONSIBILITY AND CONTINUOUS LEARNING.

LIMITATIONS ON INDEPENDENT PRACTICE

CONVERSELY, RESTRICTIVE PRACTICE AGREEMENTS MAY LIMIT NURSE PRACTITIONERS' ABILITY TO DELIVER TIMELY CARE, POTENTIALLY CAUSING DELAYS IN TREATMENT AND REDUCING OVERALL HEALTHCARE ACCESSIBILITY. SUCH LIMITATIONS CAN ALSO AFFECT JOB SATISFACTION AND PROFESSIONAL GROWTH.
