TRAPEZOIDAL RULE

$$T(h) = \frac{h}{2} \left[f(a) + 2 \sum_{k=1}^{n-1} f(a + kh) + f(b) \right]$$

WHERE $h = \frac{b-a}{n}$ IS THE STEP SIZE AND n IS THE NUMBER OF SUBINTERVALS.

RICHARDSON EXTRAPOLATION

RICHARDSON EXTRAPOLATION IS USED TO ENHANCE THE ACCURACY OF NUMERICAL APPROXIMATIONS BY COMBINING ESTIMATES WITH DIFFERENT STEP SIZES. GIVEN TWO TRAPEZOIDAL APPROXIMATIONS $T(h)$ AND $T(h/2)$, THE IMPROVED ESTIMATE R IS CALCULATED AS:

$$R = \frac{4 T(h/2) - T(h)}{3}$$

THIS PROCESS CAN BE REPEATED ITERATIVELY TO BUILD A ROMBERG INTEGRATION TABLE WITH INCREASINGLY ACCURATE VALUES.

ROMBERG TABLE CONSTRUCTION

- CALCULATE $R_{k,1} = T(h_k)$ FOR $k = 1, 2, \dots$
- FOR $j > 1$, COMPUTE $R_{k,j} = \frac{4^{j-1} R_{k+1,j-1} - R_{k,j-1}}{4^{j-1} - 1}$

THE VALUE $R_{1,m}$ IN THE TOP-RIGHT OF THE TABLE PROVIDES THE MOST ACCURATE INTEGRAL APPROXIMATION AFTER m ITERATIONS.

ADVANTAGES OF ROMBERG INTEGRATION
