

# ROMEO AND JULIET LAW SAN DIEGO

## OVERVIEW OF ROMEO AND JULIET LAW IN SAN DIEGO

THE ROMEO AND JULIET LAW IN SAN DIEGO IS A STATUTORY PROVISION AIMED AT MITIGATING HARSH PENALTIES ASSOCIATED WITH CONSENSUAL SEXUAL RELATIONS BETWEEN MINORS OR BETWEEN A MINOR AND A YOUNG ADULT CLOSE IN AGE. NAMED COLLOQUIALLY AFTER SHAKESPEARE'S YOUNG STAR-CROSSED LOVERS, THIS LAW RECOGNIZES THAT CONSENSUAL RELATIONSHIPS AMONG PEERS SHOULD NOT RESULT IN SEVERE CRIMINAL CONSEQUENCES SUCH AS MANDATORY REGISTRATION AS A SEX OFFENDER. IN CALIFORNIA, THE LAW IS DESIGNED TO PROVIDE A SAFE HARBOR FOR INDIVIDUALS WHO MIGHT OTHERWISE FACE DISPROPORTIONATE CHARGES UNDER STRICT STATUTORY RAPE STATUTES.

## PURPOSE AND BACKGROUND

THIS LAW EXISTS TO ADDRESS THE GAP IN THE LEGAL SYSTEM WHERE STRICT AGE OF CONSENT LAWS COULD CRIMINALIZE CONSENSUAL SEXUAL ACTIVITY AMONG TEENAGERS OR YOUNG ADULTS WITH MINOR AGE DIFFERENCES. IT DOES NOT APPLY TO CASES INVOLVING FORCE, COERCION, OR SIGNIFICANT AGE DISPARITIES. THE LAW PRIMARILY IMPACTS STATUTORY RAPE CHARGES, REDUCING OR ELIMINATING MANDATORY PENALTIES SUCH AS SEX OFFENDER REGISTRATION, WHICH CAN PROFOUNDLY AFFECT THE FUTURE OF YOUNG INDIVIDUALS.

# ELIGIBILITY CRITERIA FOR ROMEO AND JULIET LAW

TO QUALIFY FOR PROTECTIONS UNDER THE ROMEO AND JULIET LAW IN SAN DIEGO, SEVERAL SPECIFIC ELIGIBILITY CRITERIA MUST BE MET. THESE CRITERIA ARE STRICTLY DEFINED AND FOCUS ON THE AGES OF THE INDIVIDUALS INVOLVED AND THE NATURE OF THE SEXUAL ACTIVITY.

## AGE REQUIREMENTS

TYPICALLY, THE LAW APPLIES WHEN ONE PARTY IS BELOW THE AGE OF CONSENT, WHICH IS 18 IN CALIFORNIA, BUT IS WITHIN THREE YEARS OF AGE DIFFERENCE FROM THE OTHER PARTY. HOWEVER, IF ONE PARTY IS SIGNIFICANTLY OLDER, SUCH AS AN ADULT OVER 21, THE PROTECTIONS ARE UNLIKELY TO APPLY.

## CONSENSUAL NATURE OF RELATIONSHIP

CONSENT IS A CRITICAL ELEMENT FOR THE ROMEO AND JULIET LAW TO APPLY. THE SEXUAL ACTIVITY MUST BE CONSENSUAL AND FREE FROM FORCE, MANIPULATION, OR COERCION. ANY INDICATION OF ABUSE OR EXPLOITATION DISQUALIFIES THE CASE FROM PROTECTIONS UNDER THIS STATUTE.

## TYPE OF SEXUAL ACTIVITY COVERED

THE LAW GENERALLY COVERS CONSENSUAL SEXUAL INTERCOURSE AND MAY EXTEND TO OTHER SEXUAL ACTIVITIES DEPENDING ON THE CIRCUMSTANCES AND SPECIFIC CHARGES. IT IS IMPORTANT TO CONSULT LEGAL DEFINITIONS AND INTERPRETATIONS TO UNDERSTAND THE EXACT SCOPE IN INDIVIDUAL CASES.

## LEGAL IMPLICATIONS AND PROTECTIONS

## AVOIDANCE OF SEX OFFENDER REGISTRATION

PERHAPS THE MOST SIGNIFICANT PROTECTION IS THE POSSIBLE EXEMPTION FROM MANDATORY SEX OFFENDER REGISTRATION. REGISTERING AS A SEX OFFENDER CARRIES SEVERE LONG-TERM CONSEQUENCES FOR EMPLOYMENT, EDUCATION, AND HOUSING. THE ROMEO AND JULIET LAW HELPS PREVENT THIS OUTCOME FOR ELIGIBLE INDIVIDUALS.

## IMPACT ON CRIMINAL RECORD

IN ADDITION TO REDUCING CHARGES, THE LAW CAN HELP LIMIT THE IMPACT ON A YOUNG PERSON'S CRIMINAL RECORD. THIS CAN BE CRUCIAL FOR THEIR FUTURE OPPORTUNITIES AND SOCIAL INTEGRATION.

# PROCESS FOR SEEKING RELIEF UNDER ROMEO AND JULIET LAW

## IMPORTANT CONSIDERATIONS

UNDERSTANDING THE PRECISE AGE DIFFERENCES, CONSENT FACTORS, AND LEGAL DEFINITIONS IS CRITICAL. FAMILIES AND INDIVIDUALS SHOULD CONSULT KNOWLEDGEABLE LEGAL COUNSEL IN SAN DIEGO TO EVALUATE THEIR SITUATION PROPERLY.
