THE SWMS MUST BE AUTHORIZED BY COMPETENT PERSONNEL AND REGULARLY REVIEWED TO MAINTAIN RELEVANCE AND EFFECTIVENESS. DOCUMENTATION OF REVIEWS AND UPDATES IS CRITICAL FOR COMPLIANCE AND CONTINUOUS SAFETY IMPROVEMENT.

DEVELOPING AN EFFECTIVE SAFE WORK METHOD STATEMENT ELECTRICAL

2. **SUBSTITUTION:** REPLACING HAZARDOUS ELECTRICAL EQUIPMENT OR METHODS WITH SAFER ALTERNATIVES.
3. **ENGINEERING CONTROLS:** INSTALLING PHYSICAL BARRIERS OR SAFETY DEVICES TO PREVENT EXPOSURE.
4. **ADMINISTRATIVE CONTROLS:** IMPLEMENTING POLICIES, TRAINING, AND PROCEDURES TO REDUCE RISK.
5. **PERSONAL PROTECTIVE EQUIPMENT (PPE):** USING GLOVES, INSULATED TOOLS, AND PROTECTIVE CLOTHING AS A LAST LINE OF DEFENSE.

SAFE WORK PRACTICES

KEY SAFETY PROCEDURES INCLUDE:

- LOCKOUT/TAGOUT PROTOCOLS TO ENSURE EQUIPMENT IS DE-ENERGIZED BEFORE WORK

CONTINUOUS IMPROVEMENT

EMBEDDING A CULTURE OF CONTINUOUS IMPROVEMENT ENCOURAGES PROACTIVE IDENTIFICATION OF HAZARDS AND ADOPTION OF BEST PRACTICES, THEREBY ENHANCING OVERALL ELECTRICAL SAFETY MANAGEMENT.
