OVERVIEW OF SHERBURNE WILDLIFE MANAGEMENT AREA

SHERBURNE WILDLIFE MANAGEMENT AREA IS A PROTECTED REGION DEDICATED TO WILDLIFE CONSERVATION AND PUBLIC HUNTING OPPORTUNITIES. LOCATED IN MINNESOTA, THE WMA COVERS THOUSANDS OF ACRES OF DIVERSE HABITATS, INCLUDING WETLANDS, FORESTS, AND GRASSLANDS. THESE ENVIRONMENTS SUPPORT A WIDE VARIETY OF GAME SPECIES, MAKING SHERBURNE WMA A POPULAR DESTINATION FOR HUNTERS THROUGHOUT THE YEAR. THE AREA IS MANAGED BY STATE WILDLIFE AGENCIES TO BALANCE ECOSYSTEM HEALTH WITH RECREATIONAL HUNTING AND FISHING ACTIVITIES. AS SUCH, ADHERENCE TO THE SHERBURNE WMA HUNTING SCHEDULE AND POSTED REGULATIONS IS ESSENTIAL TO MAINTAIN THE AREA'S NATURAL RESOURCES.

ANNUAL HUNTING SEASONS IN SHERBURNE WMA

THE SHERBURNE WMA HUNTING SCHEDULE IS ORGANIZED AROUND SPECIFIC GAME SPECIES, EACH WITH DESIGNATED OPEN AND CLOSED SEASONS. THE TIMING OF THESE SEASONS ALIGNS WITH STATE WILDLIFE MANAGEMENT OBJECTIVES TO ENSURE SUSTAINABLE POPULATIONS. BELOW IS AN OUTLINE OF THE PRIMARY HUNTING SEASONS AVAILABLE IN SHERBURNE WMA.

DEER HUNTING SEASON

DEER HUNTING IS ONE OF THE MOST POPULAR ACTIVITIES IN SHERBURNE WMA. THE SEASON TYPICALLY INCLUDES ARCHERY, FIREARMS, AND MUZZLELOADER SEGMENTS. THE ARCHERY SEASON USUALLY OPENS IN EARLY SEPTEMBER AND RUNS THROUGH LATE NOVEMBER. FIREARMS SEASON STARTS IN MID-NOVEMBER AND EXTENDS TO EARLY DECEMBER, WITH A SEPARATE MUZZLELOADER SEASON OCCURRING SHORTLY AFTER. HUNTERS SHOULD CONSULT THE CURRENT SHERBURNE WMA HUNTING SCHEDULE FOR EXACT DATES AS THEY MAY VARY ANNUALLY BASED ON WILDLIFE MANAGEMENT DECISIONS.

TURKEY HUNTING SEASON

SPRING TURKEY HUNTING OFFERS AN EXCITING OPPORTUNITY FOR UPLAND GAME HUNTERS. THE SPRING SEASON GENERALLY OPENS IN MID-APRIL AND LASTS FOR SEVERAL WEEKS. A FALL TURKEY SEASON MAY ALSO BE AVAILABLE, USUALLY BEGINNING IN SEPTEMBER. BOTH SEASONS REQUIRE HUNTERS TO POSSESS THE APPROPRIATE TURKEY PERMITS AND FOLLOW BAG LIMITS ESTABLISHED TO PROTECT THE TURKEY POPULATION.

WATERFOWL HUNTING SEASON

WATERFOWL HUNTING IN SHERBURNE WMA FOCUSES ON DUCKS AND GEESE THAT MIGRATE THROUGH THE AREA'S WETLANDS. THE SEASON TYPICALLY BEGINS IN EARLY OCTOBER AND RUNS THROUGH LATE JANUARY, WITH SPECIFIC DATES SET BY FEDERAL AND STATE REGULATIONS. HUNTERS MUST ADHERE TO DAILY BAG LIMITS AND SPECIES RESTRICTIONS AS OUTLINED IN THE SHERBURNE WMA HUNTING SCHEDULE AND ACCOMPANYING REGULATIONS.

SMALL GAME AND UPLAND BIRD SEASONS

IN ADDITION TO BIG GAME AND WATERFOWL, THE SHERBURNE WMA HUNTING SCHEDULE INCLUDES SEASONS FOR SMALL GAME SUCH AS RABBITS, SQUIRRELS, AND UPLAND BIRDS LIKE PHEASANTS AND GROUSE. THESE SEASONS OFTEN RUN FROM EARLY FALL THROUGH WINTER, PROVIDING EXTENDED HUNTING OPPORTUNITIES. SPECIFIC DATES AND BAG LIMITS ARE DETAILED IN THE STATE'S HUNTING REGULATIONS HANDBOOK.

- ARCHERY DEER SEASON: EARLY SEPTEMBER TO LATE NOVEMBER
- FIREARMS DEER SEASON: MID-NOVEMBER TO EARLY DECEMBER
- MUZZLELOADER DEER SEASON: EARLY DECEMBER
- SPRING TURKEY SEASON: MID-APRIL FOR SEVERAL WEEKS
- FALL TURKEY SEASON: BEGINNING IN SEPTEMBER
- WATERFOWL SEASON: EARLY OCTOBER TO LATE JANUARY
- SMALL GAME SEASON: EARLY FALL THROUGH WINTER

PERMIT AND LICENSING REQUIREMENTS

COMPLIANCE WITH PERMIT AND LICENSING REQUIREMENTS IS VITAL WHEN FOLLOWING THE SHERBURNE WMA HUNTING SCHEDULE. HUNTERS MUST OBTAIN THE APPROPRIATE LICENSES AND PERMITS ISSUED BY THE MINNESOTA DEPARTMENT OF NATURAL RESOURCES (DNR) OR THE RELEVANT AUTHORITY. THESE PERMITS VARY DEPENDING ON THE GAME SPECIES AND TYPE OF HUNTING.

GENERAL HUNTING LICENSE

ALL HUNTERS IN SHERBURNE WMA NEED A VALID MINNESOTA HUNTING LICENSE. THIS LICENSE GRANTS ACCESS TO MOST GAME SPECIES DURING OPEN SEASONS AND IS AVAILABLE IN VARIOUS FORMS SUCH AS RESIDENT, NON-RESIDENT, AND YOUTH LICENSES.

SPECIAL PERMITS AND TAGS

CERTAIN SPECIES REQUIRE ADDITIONAL PERMITS OR TAGS, INCLUDING:

- DEER TAGS FOR FIREARMS, ARCHERY, AND MUZZLELOADER SEASONS
- TURKEY PERMITS FOR SPRING AND FALL SEASONS
- WATERFOWL STAMPS FOR HUNTING DUCKS AND GEESE
- SMALL GAME PERMITS AS REQUIRED

THESE PERMITS HELP REGULATE HARVEST LEVELS AND SUPPORT CONSERVATION EFFORTS.

APPLICATION AND DRAWING PROCESS

SOME PERMITS, ESPECIALLY FOR DEER AND TURKEY, MAY BE LIMITED IN NUMBER AND DISTRIBUTED THROUGH A DRAWING OR LOTTERY SYSTEM. HUNTERS SHOULD APPLY IN ADVANCE AND VERIFY PERMIT AVAILABILITY BEFORE PLANNING THEIR TRIP. THE SHERBURNE WMA HUNTING SCHEDULE IS COORDINATED WITH THESE PERMIT ISSUANCE TIMELINES.

HUNTING REGULATIONS AND RESTRICTIONS

ADHERING TO HUNTING REGULATIONS AND RESTRICTIONS IS CRUCIAL WITHIN SHERBURNE WMA TO ENSURE SAFETY, LEGALITY, AND CONSERVATION GOALS. THE SHERBURNE WMA HUNTING SCHEDULE INCORPORATES THESE RULES TO GUIDE HUNTERS THROUGHOUT THE YEAR.

AREA-SPECIFIC RULES

SAFETY REGULATIONS INCLUDE WEARING BLAZE ORANGE DURING FIREARM SEASONS, MAINTAINING SAFE DISTANCES FROM OTHER HUNTERS, AND RESPECTING PRIVATE PROPERTY BOUNDARIES. ETHICAL HUNTING INVOLVES FAIR CHASE PRINCIPLES, PROPER GAME HANDLING, AND MINIMIZING ENVIRONMENTAL IMPACT.

BEST PRACTICES FOR HUNTING IN SHERBURNE WMA

RESPECTING WILDLIFE AND HABITAT

MINIMIZE DISTURBANCE TO WILDLIFE BY FOLLOWING DESIGNATED TRAILS, AVOIDING SENSITIVE HABITATS, AND ADHERING TO HUNTING BOUNDARIES. PRACTICING ETHICAL HUNTING ENSURES THE SUSTAINABILITY OF GAME POPULATIONS FOR FUTURE SEASONS.

SAFETY MEASURES

ALWAYS INFORM OTHERS OF YOUR HUNTING PLANS, CARRY COMMUNICATION DEVICES, AND BE PREPARED FOR CHANGING WEATHER CONDITIONS. FOLLOW ALL SAFETY GUIDELINES RELATED TO WEAPON HANDLING AND FIELD DRESSING OF GAME.

- CHECK UPDATED SHERBURNE WMA HUNTING SCHEDULE ANNUALLY
- SECURE ALL NECESSARY LICENSES AND PERMITS BEFOREHAND
- SCOUT AND FAMILIARIZE WITH TERRAIN AND ACCESS POINTS
- FOLLOW ALL POSTED RULES AND AREA-SPECIFIC RESTRICTIONS
- PRACTICE RESPONSIBLE AND ETHICAL HUNTING METHODS
- REPORT HARVESTS AS REQUIRED BY REGULATIONS

FREQUENTLY ASKED QUESTIONS

WHAT IS THE CURRENT HUNTING SCHEDULE FOR SHERBURNE WILDLIFE MANAGEMENT AREA (WMA)?

THE SHERBURNE WMA HUNTING SCHEDULE VARIES BY SEASON AND SPECIES. GENERALLY, DEER HUNTING IS ALLOWED DURING THE DESIGNATED FIREARM AND ARCHERY SEASONS, WHILE WATERFOWL HUNTING FOLLOWS STATE MIGRATORY BIRD REGULATIONS. IT'S BEST TO CHECK THE MINNESOTA DNR WEBSITE FOR THE MOST UP-TO-DATE SCHEDULE.

ARE THERE SPECIFIC DATES FOR TURKEY HUNTING AT SHERBURNE WMA?

CAN I HUNT SMALL GAME YEAR-ROUND AT SHERBURNE WMA?
