WHAT IS THE STATEMENT OF HEALTH FORM METLIFE?

PURPOSE OF THE STATEMENT OF HEALTH FORM

THE FORM REQUIRES A LIST OF ANY PRESCRIBED MEDICATIONS AND TREATMENTS THE APPLICANT IS CURRENTLY UNDERGOING. THIS INFORMATION HELPS UNDERWRITERS ASSESS THE SEVERITY AND MANAGEMENT OF ANY HEALTH CONDITIONS.

LIFESTYLE AND HABITS

QUESTIONS ABOUT TOBACCO USE, ALCOHOL CONSUMPTION, DRUG USE, AND OCCUPATIONAL HAZARDS ARE INCLUDED TO EVALUATE LIFESTYLE FACTORS THAT MAY AFFECT RISK LEVELS. HONEST ANSWERS IN THIS SECTION ARE CRUCIAL FOR ACCURATE RISK ASSESSMENT.

RECENT HEALTH CHANGES

APPLICANTS MUST REPORT ANY RECENT CHANGES IN HEALTH STATUS, SUCH AS HOSPITAL ADMISSIONS, DIAGNOSTIC TESTS, OR NEW DIAGNOSES. THIS SECTION HELPS IDENTIFY ANY IMMEDIATE RISKS THAT MAY INFLUENCE COVERAGE DECISIONS.

HOW TO COMPLETE THE STATEMENT OF HEALTH FORM

HOW LONG DOES IT TAKE FOR METLIFE TO PROCESS A STATEMENT OF HEALTH FORM?
