THE LOS ANGELES UNIFIED SCHOOL DISTRICT, ALONG WITH OTHER SCHOOL DISTRICTS IN THE AREA, FOLLOWS GUIDELINES ESTABLISHED BY THE CALIFORNIA COMMISSION ON TEACHER CREDENTIALING (CTC). THESE REGULATIONS ENSURE THAT SUBSTITUTE TEACHERS POSSESS THE NECESSARY KNOWLEDGE AND SKILLS TO MAINTAIN A PRODUCTIVE LEARNING ENVIRONMENT.

MINIMUM EDUCATIONAL QUALIFICATIONS

THE CALIFORNIA CTC ISSUES DIFFERENT TYPES OF SUBSTITUTE TEACHING CREDENTIALS THAT CANDIDATES MUST OBTAIN. THE MOST COMMON CREDENTIALS INCLUDE:

- **30-DAY SUBSTITUTE TEACHING PERMIT:** THIS PERMIT ALLOWS AN INDIVIDUAL TO SUBSTITUTE FOR UP TO 30 DAYS IN A SINGLE ASSIGNMENT WITHIN A SCHOOL YEAR. IT REQUIRES A BACHELOR'S DEGREE AND PASSING THE CALIFORNIA BASIC EDUCATIONAL SKILLS TEST (CBEST) OR AN EQUIVALENT BASIC SKILLS REQUIREMENT.

- **EMERGENCY SUBSTITUTE TEACHING PERMIT:** ISSUED TO INDIVIDUALS WHO HAVE A BACHELOR'S DEGREE AND ARE IN THE PROCESS OF EARNING A TEACHING CREDENTIAL. THIS PERMIT IS VALID FOR A LIMITED TIME AND ALLOWS MORE FLEXIBILITY IN ASSIGNMENTS.
- **STANDARD SUBSTITUTE TEACHING CREDENTIAL:** THIS CREDENTIAL IS OFTEN ISSUED TO FULLY CREDENTIALLED TEACHERS WHO WISH TO WORK AS SUBSTITUTES.

CHOOSING THE CORRECT CREDENTIAL DEPENDS ON THE CANDIDATE'S QUALIFICATIONS AND CAREER GOALS.

APPLICATION PROCESS AND BACKGROUND CHECKS

ADDITIONALLY, CANDIDATES MUST CLEAR THE CHILD ABUSE INDEX AND DEMONSTRATE A CLEAN RECORD TO BE ELIGIBLE FOR HIRE.

BACKGROUND CHECKS ARE MANDATORY AND MUST BE COMPLETED BEFORE ANY SUBSTITUTE TEACHING ASSIGNMENT.

WORKING CONDITIONS AND RESPONSIBILITIES

WORK ENVIRONMENT AND SCHEDULING
