OVERVIEW OF TSP LIFECYCLE FUNDS

TSP LIFECYCLE FUNDS, ALSO KNOWN AS L FUNDS, ARE TARGET-DATE FUNDS DESIGNED SPECIFICALLY FOR TSP PARTICIPANTS. THESE FUNDS AUTOMATICALLY ADJUST THEIR ASSET ALLOCATION OVER TIME BASED ON THE PARTICIPANT'S ESTIMATED RETIREMENT DATE. THE GOAL IS TO PROVIDE A DIVERSIFIED PORTFOLIO THAT GRADUALLY SHIFTS FROM HIGHER-RISK INVESTMENTS TO MORE CONSERVATIVE ONES AS THE TARGET DATE APPROACHES. THIS RISK ADJUSTMENT AIMS TO OPTIMIZE RETURNS WHILE MINIMIZING THE POTENTIAL FOR SIGNIFICANT LOSSES NEAR RETIREMENT.

STRUCTURE AND COMPOSITION

THE TSP LIFECYCLE FUNDS INVEST IN A MIX OF THE FIVE INDIVIDUAL TSP FUNDS: THE GOVERNMENT SECURITIES INVESTMENT FUND (G FUND), THE FIXED INCOME INDEX INVESTMENT FUND (F FUND), THE COMMON STOCK INDEX INVESTMENT FUND (C FUND), THE SMALL CAPITALIZATION STOCK INDEX INVESTMENT FUND (S FUND), AND THE INTERNATIONAL STOCK INDEX INVESTMENT FUND (I FUND). THE ALLOCATION PERCENTAGES CHANGE ANNUALLY TO ALIGN WITH THE FUND'S TARGET RETIREMENT DATE. EARLY IN THE LIFECYCLE, THE FUNDS ARE HEAVILY WEIGHTED TOWARDS STOCKS TO MAXIMIZE GROWTH POTENTIAL. AS THE RETIREMENT DATE NEARS, THE ALLOCATION SHIFTS TOWARDS BONDS AND GOVERNMENT SECURITIES TO REDUCE VOLATILITY.

TYPES OF LIFECYCLE FUNDS

THE TSP OFFERS SEVERAL LIFECYCLE FUNDS, EACH IDENTIFIED BY A TARGET RETIREMENT YEAR, SUCH AS L 2025, L 2030, L 2040, L 2050, AND L 2060. THERE IS ALSO AN L INCOME FUND DESIGNED FOR PARTICIPANTS ALREADY IN RETIREMENT OR NEAR RETIREMENT. THE SELECTION OF A SPECIFIC LIFECYCLE FUND DEPENDS ON THE PARTICIPANT'S EXPECTED RETIREMENT TIMELINE, ENSURING THAT INVESTMENT RISK ALIGNS WITH THE INVESTOR'S TIME HORIZON AND FINANCIAL GOALS.

HISTORICAL PERFORMANCE OF TSP LIFECYCLE FUNDS

EXAMINING THE HISTORICAL PERFORMANCE OF TSP LIFECYCLE FUNDS PROVIDES VALUABLE INSIGHT INTO THEIR EFFECTIVENESS AS RETIREMENT INVESTMENT VEHICLES. PERFORMANCE IS TYPICALLY MEASURED BY ANNUALIZED RETURNS, VOLATILITY, AND RISK-ADJUSTED METRICS OVER VARIOUS TIMEFRAMES. FUNDS WITH LONGER TIME HORIZONS, SUCH AS L 2050 AND L 2060, HAVE GENERALLY DELIVERED HIGHER RETURNS DUE TO THEIR GREATER ALLOCATION TO EQUITIES. CONVERSELY, FUNDS CLOSER TO RETIREMENT, LIKE L 2025 AND L INCOME, HAVE SHOWN MORE MODERATE RETURNS WITH LOWER VOLATILITY, REFLECTING THEIR CONSERVATIVE INVESTMENT MIX.

PERFORMANCE DURING MARKET VOLATILITY

DURING PERIODS OF MARKET DOWNTURNS, SUCH AS THE 2008 FINANCIAL CRISIS AND THE 2020 COVID-19 PANDEMIC-INDUCED SELL-OFF, LIFECYCLE FUNDS WITH MORE CONSERVATIVE ALLOCATIONS FARED BETTER BY PRESERVING CAPITAL. FUNDS TARGETING RETIREMENT DATES FURTHER IN THE FUTURE EXPERIENCED GREATER FLUCTUATIONS BUT ALSO BENEFITED FROM QUICKER RECOVERIES DUE TO THEIR EQUITY EXPOSURE. THIS HIGHLIGHTS THE IMPORTANCE OF SELECTING A LIFECYCLE FUND THAT MATCHES AN INVESTOR'S RISK TOLERANCE AND RETIREMENT TIMELINE.

FACTORS AFFECTING TSP LIFECYCLE FUND PERFORMANCE

SEVERAL KEY FACTORS INFLUENCE THE PERFORMANCE OF TSP LIFECYCLE FUNDS. UNDERSTANDING THESE ELEMENTS HELPS INVESTORS ANTICIPATE POTENTIAL CHANGES IN RETURNS AND MAKE ADJUSTMENTS AS NECESSARY.

MARKET CONDITIONS

THE PERFORMANCE OF LIFECYCLE FUNDS IS DIRECTLY INFLUENCED BY THE OVERALL MARKET ENVIRONMENT. BULL MARKETS TYPICALLY ENHANCE GROWTH FOR FUNDS WITH HIGHER STOCK ALLOCATIONS, WHILE BEAR MARKETS CAN REDUCE RETURNS, ESPECIALLY FOR THOSE HEAVILY INVESTED IN EQUITIES. INTEREST RATE CHANGES, INFLATION, AND ECONOMIC CYCLES ALSO IMPACT BOND AND STOCK RETURNS WITHIN THE FUNDS.

ASSET ALLOCATION ADJUSTMENTS

LIFECYCLE FUNDS SYSTEMATICALLY ADJUST THEIR ASSET ALLOCATION EACH YEAR TO REDUCE RISK AS THE TARGET DATE APPROACHES. THIS GRADUAL SHIFT FROM EQUITIES TO FIXED INCOME AND GOVERNMENT SECURITIES HELPS PROTECT THE PORTFOLIO FROM MARKET VOLATILITY BUT MAY ALSO LIMIT UPSIDE POTENTIAL DURING STRONG MARKET RALLIES. THE BALANCE ACHIEVED THROUGH THESE ADJUSTMENTS IS CRITICAL TO THE FUND'S LONG-TERM PERFORMANCE.

FEES AND EXPENSES

TSP LIFECYCLE FUNDS BENEFIT FROM THE LOW-COST STRUCTURE OF THE TSP PROGRAM. EXPENSE RATIOS ARE MINIMAL COMPARED TO MANY OTHER MUTUAL FUNDS, WHICH POSITIVELY IMPACTS NET RETURNS OVER TIME. LOWER FEES MEAN MORE OF THE INVESTMENT EARNINGS REMAIN IN THE PARTICIPANT'S ACCOUNT, ENHANCING OVERALL PERFORMANCE.

COMPARING LIFECYCLE FUNDS TO OTHER TSP INVESTMENT OPTIONS

BESIDES LIFECYCLE FUNDS, TSP PARTICIPANTS CAN CHOOSE FROM FIVE INDIVIDUAL FUNDS, EACH WITH DISTINCT RISK AND RETURN CHARACTERISTICS. COMPARING THESE OPTIONS HELPS INVESTORS DETERMINE THE SUITABILITY OF LIFECYCLE FUNDS WITHIN THEIR INVESTMENT STRATEGY.

INDIVIDUAL TSP FUNDS

THE FIVE INDIVIDUAL TSP FUNDS ARE:

- **G FUND:** GOVERNMENT SECURITIES WITH MINIMAL RISK AND STABLE RETURNS.
- **F FUND:** FIXED INCOME SECURITIES TRACKING THE BLOOMBERG BARCLAYS U.S. AGGREGATE BOND INDEX.
- **C FUND:** LARGE-CAP U.S. STOCKS TRACKING THE S&P 500 INDEX.
- **S FUND:** SMALL TO MID-CAP U.S. STOCKS NOT INCLUDED IN THE S&P 500.
- **I FUND:** INTERNATIONAL STOCKS FROM DEVELOPED MARKETS OUTSIDE THE U.S.

RISK AND RETURN PROFILES

INDIVIDUAL FUNDS OFFER MORE CONTROL OVER ASSET ALLOCATION BUT REQUIRE ACTIVE MANAGEMENT BY THE PARTICIPANT. LIFECYCLE FUNDS AUTOMATE THIS PROCESS, ADJUSTING ALLOCATIONS TO MAINTAIN AN APPROPRIATE RISK LEVEL OVER TIME. FOR INVESTORS SEEKING SIMPLICITY AND A HANDS-OFF APPROACH, LIFECYCLE FUNDS PROVIDE A BALANCED AND DIVERSIFIED OPTION. CONVERSELY, THOSE WILLING TO MONITOR AND ADJUST THEIR PORTFOLIO MAY BENEFIT FROM COMBINING INDIVIDUAL FUNDS TO TAILOR RISK AND RETURN MORE PRECISELY.

STRATEGIES TO OPTIMIZE TSP LIFECYCLE FUND RETURNS

MAXIMIZING THE PERFORMANCE OF TSP LIFECYCLE FUNDS INVOLVES STRATEGIC PLANNING AND PERIODIC REVIEW TO ENSURE ALIGNMENT WITH RETIREMENT GOALS.

REGULAR MONITORING AND REBALANCING

WHILE LIFECYCLE FUNDS AUTOMATICALLY REBALANCE ASSET ALLOCATIONS, PARTICIPANTS SHOULD PERIODICALLY REVIEW THEIR FUND SELECTION TO CONFIRM IT MATCHES THEIR CHANGING RETIREMENT TIMELINE AND RISK TOLERANCE. LIFE EVENTS, MARKET SHIFTS, AND CHANGES IN FINANCIAL GOALS MAY NECESSITATE SWITCHING TO A DIFFERENT LIFECYCLE FUND OR SUPPLEMENTING WITH INDIVIDUAL FUNDS.

DIVERSIFICATION CONSIDERATIONS

ALTHOUGH LIFECYCLE FUNDS ARE DIVERSIFIED ACROSS MULTIPLE ASSET CLASSES, SOME INVESTORS MAY CHOOSE TO ENHANCE DIVERSIFICATION BY ALLOCATING A PORTION OF THEIR TSP CONTRIBUTIONS TO INDIVIDUAL FUNDS. THIS APPROACH CAN PROVIDE EXPOSURE TO SPECIFIC SECTORS OR REGIONS NOT FULLY REPRESENTED IN THE LIFECYCLE FUNDS, POTENTIALLY IMPROVING OVERALL PORTFOLIO PERFORMANCE.

STARTING EARLY AND CONSISTENT CONTRIBUTIONS

EARLY AND CONSISTENT CONTRIBUTIONS TO THE TSP LIFECYCLE FUNDS CAPITALIZE ON THE POWER OF COMPOUNDING AND MARKET GROWTH. THE LONGER THE INVESTMENT HORIZON, THE GREATER THE POTENTIAL TO BENEFIT FROM EQUITY MARKET APPRECIATION WITHIN THE FUNDS. PARTICIPANTS WHO BEGIN SAVING EARLY AND MAINTAIN REGULAR CONTRIBUTIONS ARE BETTER POSITIONED TO ACHIEVE FAVORABLE RETIREMENT OUTCOMES.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE TSP LIFECYCLE FUND?

THE TSP LIFECYCLE FUND IS A TARGET-DATE INVESTMENT FUND OFFERED BY THE THRIFT SAVINGS PLAN (TSP) THAT AUTOMATICALLY ADJUSTS ITS ASSET ALLOCATION BASED ON THE PARTICIPANT'S EXPECTED RETIREMENT DATE.

HOW IS THE PERFORMANCE OF TSP LIFECYCLE FUNDS MEASURED?

PERFORMANCE IS TYPICALLY MEASURED BY THE FUND'S TOTAL RETURN, WHICH INCLUDES CAPITAL GAINS, DIVIDENDS, AND INTEREST, COMPARED AGAINST BENCHMARK INDICES AND OTHER SIMILAR TARGET-DATE FUNDS OVER VARIOUS TIME PERIODS.

WHICH FACTORS INFLUENCE THE PERFORMANCE OF TSP LIFECYCLE FUNDS?

TSP LIFECYCLE FUNDS HAVE VERY LOW ADMINISTRATIVE AND MANAGEMENT FEES COMPARED TO MANY PRIVATE SECTOR MUTUAL FUNDS, MAKING THEM COST-EFFECTIVE INVESTMENT OPTIONS.

HOW DOES THE ASSET ALLOCATION CHANGE IN TSP LIFECYCLE FUNDS OVER TIME?
