THE VANGUARD TRANSAMERICA VARIABLE ANNUITY COMBINES VANGUARD'S REPUTATION FOR LOW-COST, DIVERSIFIED INVESTMENT FUNDS WITH TRANSAMERICA'S EXPERTISE IN ANNUITIES AND INSURANCE PRODUCTS. THIS ANNUITY IS DESIGNED TO HELP INVESTORS ACCUMULATE WEALTH ON A TAX-DEFERRED BASIS AND PROVIDE A STREAM OF INCOME DURING RETIREMENT. IT IS A CONTRACT BETWEEN THE INVESTOR AND THE INSURANCE COMPANY, WHERE PREMIUMS ARE INVESTED IN A RANGE OF SUBACCOUNTS THAT FUNCTION SIMILARLY TO MUTUAL FUNDS. THE VALUE OF THE ANNUITY FLUCTUATES BASED ON THE PERFORMANCE OF THESE INVESTMENT OPTIONS, MAKING IT A VARIABLE ANNUITY RATHER THAN A FIXED PRODUCT.

VARIABLE ANNUITIES ARE PARTICULARLY SUITED FOR INDIVIDUALS SEEKING BOTH GROWTH POTENTIAL AND INCOME GUARANTEES. EFFICIENTLY OVER TIME. TAXES ARE ONLY DUE UPON WITHDRAWAL, WHICH CAN BE ADVANTAGEOUS FOR RETIREMENT PLANNING.

DEATH BENEFIT PROTECTION

VARIABLE ANNUITIES TYPICALLY INCLUDE A DEATH BENEFIT THAT GUARANTEES A MINIMUM PAYOUT TO BENEFICIARIES IF THE ANNUITY HOLDER PASSES AWAY. THE VANGUARD TRANSAMERICA VARIABLE ANNUITY OFTEN PROVIDES A DEATH BENEFIT EQUAL TO THE GREATER OF THE CURRENT CONTRACT VALUE OR TOTAL PREMIUMS PAID, PROTECTING THE INVESTOR'S PRINCIPAL IN ADVERSE MARKET CONDITIONS.

GUARANTEED INCOME OPTIONS

MANY VARIABLE ANNUITIES, INCLUDING THIS OFFERING, INCLUDE OPTIONAL RIDERS THAT PROVIDE GUARANTEED LIFETIME INCOME REGARDLESS OF MARKET PERFORMANCE. THESE LIVING BENEFIT RIDERS CAN CONVERT THE ACCUMULATED VALUE INTO A PREDICTABLE INCOME STREAM DURING RETIREMENT, OFFERING PEACE OF MIND AND FINANCIAL STABILITY.

FLEXIBLE PREMIUM CONTRIBUTIONS

THE VANGUARD TRANSAMERICA VARIABLE ANNUITY GENERALLY ALLOWS FOR FLEXIBLE PREMIUM PAYMENTS, ENABLING INVESTORS TO CONTRIBUTE LUMP SUMS OR MAKE PERIODIC PAYMENTS OVER TIME. THIS FLEXIBILITY HELPS ACCOMMODATE VARIOUS FINANCIAL SITUATIONS AND RETIREMENT GOALS.

SURRENDER CHARGE PERIOD

LIKE MOST ANNUITIES, THIS PRODUCT INCLUDES A SURRENDER CHARGE PERIOD DURING WHICH EARLY WITHDRAWALS MAY INCUR PENALTIES. UNDERSTANDING THE SURRENDER SCHEDULE IS CRUCIAL TO AVOID UNEXPECTED FEES AND PLAN WITHDRAWAL TIMING EFFECTIVELY.

INVESTMENT OPTIONS AND STRATEGIES

SUBACCOUNTS IN THE ANNUITY REPRESENT DIFFERENT INVESTMENT PORTFOLIOS, INCLUDING EQUITY FUNDS, BOND FUNDS, BALANCED FUNDS, AND SPECIALTY FUNDS. THESE OPTIONS ALLOW INVESTORS TO TAILOR THEIR PORTFOLIO ACCORDING TO RISK TOLERANCE, TIME HORIZON, AND INVESTMENT OBJECTIVES.

LOW-COST VANGUARD FUNDS

VANGUARD IS RENOWNED FOR ITS LOW EXPENSE RATIOS, AND THIS ADVANTAGE EXTENDS TO THE VANGUARD TRANSAMERICA VARIABLE ANNUITY. BY UTILIZING VANGUARD FUNDS, THE ANNUITY HELPS KEEP COSTS DOWN, WHICH CAN HAVE A SIGNIFICANT POSITIVE IMPACT ON LONG-TERM RETURNS.

FEES AND EXPENSES

UNDERSTANDING THE FEE STRUCTURE OF THE VANGUARD TRANSAMERICA VARIABLE ANNUITY IS ESSENTIAL FOR EVALUATING ITS COST-EFFECTIVENESS COMPARED TO OTHER RETIREMENT INVESTMENT OPTIONS.

MORTALITY AND EXPENSE RISK CHARGE

THIS FEE COMPENSATES THE INSURANCE COMPANY FOR INSURANCE RISKS AND ADMINISTRATIVE EXPENSES. IT IS TYPICALLY CHARGED AS A PERCENTAGE OF THE ACCOUNT VALUE ANNUALLY AND CAN RANGE FROM 0.75% TO 1.25% DEPENDING ON THE CONTRACT TERMS.

UNDERLYING FUND EXPENSES

SINCE THE ANNUITY INVESTS IN VANGUARD MUTUAL FUNDS, INVESTORS INCUR THE FUNDS' EXPENSE RATIOS. VANGUARD'S EXPENSE RATIOS ARE AMONG THE LOWEST IN THE INDUSTRY, OFTEN WELL BELOW 0.50%, WHICH HELPS LIMIT OVERALL COSTS.

RIDER FEES

OPTIONAL LIVING BENEFIT RIDERS, SUCH AS GUARANTEED LIFETIME WITHDRAWAL BENEFITS, GENERALLY CARRY ADDITIONAL FEES. THESE FEES CAN RANGE FROM 0.25% TO 1.00% ANNUALLY AND ARE CHARGED ON THE ACCOUNT VALUE OR BENEFIT BASE.

SURRENDER CHARGES

EARLY WITHDRAWALS DURING THE SURRENDER CHARGE PERIOD MAY TRIGGER PENALTIES, OFTEN STARTING AROUND 7-8% AND DECLINING ANNUALLY OVER A PERIOD OF 6 TO 8 YEARS. UNDERSTANDING THESE CHARGES IS IMPORTANT FOR LIQUIDITY PLANNING.

WITHDRAWAL AND INCOME OPTIONS

THE VANGUARD TRANSAMERICA VARIABLE ANNUITY PROVIDES SEVERAL OPTIONS FOR ACCESSING FUNDS AND GENERATING RETIREMENT INCOME, EACH WITH SPECIFIC RULES AND IMPLICATIONS.

SYSTEMATIC WITHDRAWALS

CONTRACT HOLDERS CAN SET UP SYSTEMATIC WITHDRAWALS TO RECEIVE REGULAR PAYMENTS FROM THEIR ANNUITY. THESE CAN BE STRUCTURED AS FIXED DOLLAR AMOUNTS OR PERCENTAGES OF THE CONTRACT VALUE.

ANNUITIZATION

ANNUITIZATION CONVERTS THE ACCUMULATED VALUE OF THE ANNUITY INTO A SERIES OF PERIODIC INCOME PAYMENTS FOR A SPECIFIED TERM OR FOR LIFE. THIS OPTION PROVIDES PREDICTABLE INCOME BUT TYPICALLY REQUIRES SURRENDERING ACCESS TO THE LUMP SUM.

GUARANTEED LIFETIME WITHDRAWAL BENEFITS

WITH THE APPROPRIATE RIDER, INVESTORS CAN WITHDRAW A FIXED PERCENTAGE OF THEIR BENEFIT BASE ANNUALLY FOR LIFE, REGARDLESS OF MARKET PERFORMANCE. THIS FEATURE CAN HELP MANAGE LONGEVITY RISK IN RETIREMENT.

TAX IMPLICATIONS OF WITHDRAWALS

WITHDRAWALS ARE SUBJECT TO INCOME TAXES ON EARNINGS AND MAY INCUR PENALTIES IF TAKEN BEFORE AGE 59½. PLANNING WITHDRAWALS CAREFULLY CAN MINIMIZE TAX CONSEQUENCES AND OPTIMIZE RETIREMENT INCOME.
