NEGATIVE SCREENING

NEGATIVE SCREENING IS ONE OF THE MOST TRADITIONAL AND WIDELY USED STRATEGIES IN SUSTAINABLE INVESTING. THIS APPROACH INVOLVES EXCLUDING COMPANIES OR SECTORS THAT DO NOT MEET CERTAIN ETHICAL OR SUSTAINABILITY CRITERIA FROM AN INVESTMENT PORTFOLIO. THE GOAL IS TO AVOID EXPOSURE TO BUSINESSES INVOLVED IN ACTIVITIES CONSIDERED HARMFUL OR CONTROVERSIAL.

DEFINITION AND PURPOSE

NEGATIVE SCREENING SYSTEMATICALLY FILTERS OUT INVESTMENTS IN INDUSTRIES SUCH AS TOBACCO, FIREARMS, FOSSIL FUELS, GAMBLING, AND HUMAN RIGHTS VIOLATIONS. BY DOING SO, INVESTORS ENSURE THEIR CAPITAL DOES NOT SUPPORT PRACTICES THAT CONFLICT WITH THEIR VALUES OR SUSTAINABILITY GOALS.

IMPLEMENTATION IN PORTFOLIOS

ASSET MANAGERS APPLY NEGATIVE SCREENS USING ESG DATA AND RESEARCH, OFTEN RELYING ON EXCLUSION LISTS TO IDENTIFY COMPANIES FAILING TO MEET MINIMUM STANDARDS. THIS STRATEGY HELPS MAINTAIN A PORTFOLIO ALIGNED WITH ETHICAL CONSIDERATIONS WITHOUT NECESSARILY SACRIFICING FINANCIAL PERFORMANCE.

ADVANTAGES AND LIMITATIONS

NEGATIVE SCREENING OFFERS SIMPLICITY AND CLARITY, APPEALING TO INVESTORS WHO WANT TO AVOID SPECIFIC SECTORS. HOWEVER, IT MAY LIMIT DIVERSIFICATION AND DOES NOT PROACTIVELY SEEK COMPANIES WITH POSITIVE SUSTAINABILITY ATTRIBUTES, FOCUSING INSTEAD ON AVOIDANCE.

POSITIVE SCREENING

POSITIVE SCREENING, ALSO KNOWN AS BEST-IN-CLASS INVESTING, INVOLVES ACTIVELY SELECTING COMPANIES THAT DEMONSTRATE SUPERIOR ESG PERFORMANCE RELATIVE TO THEIR PEERS. THIS STRATEGY EMPHASIZES INVESTMENT IN BUSINESSES THAT CONTRIBUTE POSITIVELY TO SUSTAINABLE DEVELOPMENT.

SELECTION CRITERIA

POSITIVE SCREENING EVALUATES COMPANIES BASED ON ESG RATINGS, SUSTAINABILITY REPORTS, AND PERFORMANCE METRICS. COMPANIES EXCELLING IN AREAS SUCH AS ENVIRONMENTAL MANAGEMENT, SOCIAL RESPONSIBILITY, AND CORPORATE GOVERNANCE ARE FAVORED.

BENEFITS OF POSITIVE SCREENING
