

WHAT HAPPENED TO RFK'S VOICE

EARLY CHARACTERISTICS OF RFK'S VOICE

HEALTH ISSUES AFFECTING RFK'S VOICE

THIS REPEATED STRAIN COULD CAUSE A ROUGHNESS OR RASPINESS IN HIS VOICE DURING EXTENDED SPEECHES OR RALLIES.

EFFECTS OF SMOKING

LIKE MANY PUBLIC FIGURES OF HIS ERA, RFK WAS A SMOKER, A HABIT THAT CAN HAVE DETRIMENTAL EFFECTS ON VOCAL HEALTH. SMOKING IRRITATES THE VOCAL CORDS AND RESPIRATORY TRACT, OFTEN LEADING TO CHRONIC INFLAMMATION AND A DEEPER, SOMETIMES HUSKIER VOICE. OVER TIME, THIS CONTRIBUTED TO CHANGES IN RFK'S VOCAL TIMBRE, MAKING IT SOUND LESS CLEAR AND MORE GRAVELLY, ESPECIALLY DURING THE LATER YEARS OF HIS CAREER.

IMPACT OF POLITICAL STRESS ON RFK'S VOCAL QUALITY

DURING HIS 1968 PRESIDENTIAL CAMPAIGN, RFK'S VOICE SHOWED SIGNS OF WEAR THAT WERE ATTRIBUTABLE TO BOTH OVERUSE AND STRESS. THE DEMANDING SCHEDULE OF RALLIES, DEBATES, AND MEDIA APPEARANCES REQUIRED HIM TO SPEAK FOR EXTENDED PERIODS, OFTEN IN LESS-THAN-IDEAL ACOUSTIC ENVIRONMENTS.
