THE REVELATIONS INCLUDED INTERNAL DOCUMENTS AND TESTIMONIES THAT DEMONSTRATED THE COMPANY'S EFFORTS TO MISLEAD DOCTORS, PATIENTS, AND REGULATORS ABOUT THE SAFETY AND ADDICTIVE RISKS OF THEIR PRODUCTS.

THIS PERSON ACTED OUT OF CONCERN FOR PUBLIC HEALTH AND IN RESPONSE TO OBSERVING WIDESPREAD MISUSE AND ADDICTION TIED TO OXYCONTIN PRESCRIPTIONS.

MOTIVATIONS FOR WHISTLEBLOWING

WHISTLEBLOWERS OFTEN FACE ETHICAL DILEMMAS BUT CHOOSE TO COME FORWARD DUE TO:

- CONCERNS ABOUT PATIENT SAFETY AND PUBLIC HEALTH
- FRUSTRATION WITH CORPORATE DECEPTION AND MISINFORMATION

- LEGAL OBLIGATIONS TO REPORT WRONGDOING
- DESIRE TO HOLD CORPORATIONS ACCOUNTABLE

IN THE CASE OF PURDUE PHARMA, THE WHISTLEBLOWER'S MOTIVATION WAS GROUNDED IN THE GROWING OPIOID EPIDEMIC AND THE ROLE PLAYED BY MISLEADING MARKETING TACTICS.

LEGAL ACTIONS TRIGGERED BY THE WHISTLEBLOWER

THE INFORMATION PROVIDED BY THE WHISTLEBLOWER PROMPTED EXTENSIVE LEGAL SCRUTINY OF PURDUE PHARMA. FEDERAL AND STATE GOVERNMENTS INITIATED INVESTIGATIONS AND LAWSUITS ALLEGING THAT THE COMPANY ENGAGED IN FRAUDULENT MARKETING PRACTICES THAT CONTRIBUTED TO THE OPIOID CRISIS. THESE LEGAL ACTIONS SOUGHT TO HOLD PURDUE PHARMA ACCOUNTABLE FOR THE PUBLIC HEALTH DAMAGES CAUSED BY THEIR PRODUCTS.

QUI TAM LAWSUITS AND THE FALSE CLAIMS ACT

THE WHISTLEBLOWER'S DISCLOSURES OFTEN LED TO QUI TAM LAWSUITS FILED UNDER THE FALSE CLAIMS ACT. THIS LEGAL MECHANISM ALLOWS PRIVATE INDIVIDUALS TO SUE ON BEHALF OF THE GOVERNMENT IF THEY BELIEVE A COMPANY HAS DEFRAUDED FEDERAL PROGRAMS. THE WHISTLEBLOWER IN THE PURDUE PHARMA CASE HELPED TRIGGER SETTLEMENTS AND PENALTIES BY REVEALING HOW THE COMPANY'S MISREPRESENTATIONS LED TO IMPROPER HEALTHCARE CLAIMS AND PRESCRIPTIONS.

MAJOR SETTLEMENTS AND LEGAL OUTCOMES

PURDUE PHARMA FACED MULTI-BILLION-DOLLAR SETTLEMENTS AS A RESULT OF LAWSUITS INFLUENCED BY WHISTLEBLOWER EVIDENCE. THESE SETTLEMENTS INCLUDED:

PURDUE PHARMA'S ROLE IN THE OPIOID CRISIS

- PROMOTING HIGHER DOSES AND EXTENDED-RELEASE FORMULAS
- DOWNPLAYING THE POTENTIAL FOR ABUSE AND DEPENDENCY

THESE PRACTICES CONTRIBUTED TO WIDESPREAD OPIOID USE AND THE SUBSEQUENT RISE IN ADDICTION, OVERDOSE, AND DEATHS ACROSS THE COUNTRY.

INTERNAL COMPANY PRACTICES REVEALED

DOCUMENTS UNCOVERED THROUGH WHISTLEBLOWER REPORTS REVEALED THAT PURDUE PHARMA WAS AWARE OF THE ADDICTIVE POTENTIAL OF OXYCONTIN BUT CONTINUED TO MARKET IT HEAVILY.
