IT PLAYS A CRITICAL ROLE IN LICENSING, SUPERVISING, AND EXAMINING FINANCIAL ORGANIZATIONS OPERATING WITHIN WISCONSIN. THE AGENCY ALSO WORKS TO PROMOTE AN EFFICIENT AND COMPETITIVE FINANCIAL MARKETPLACE BY ENFORCING REGULATIONS AND PROVIDING CONSUMER EDUCATION.

REGULATORY FUNCTIONS AND RESPONSIBILITIES
