STAFFING PROBLEMS AND NEGLECT

UNDERSTAFFING IS A SIGNIFICANT ISSUE IN MANY OF THE WORST NURSING HOMES IN CINCINNATI. INSUFFICIENT STAFF LEVELS LEAD TO NEGLECT, DELAYED ASSISTANCE, AND INADEQUATE SUPERVISION. RESIDENTS MAY EXPERIENCE PROLONGED WAIT TIMES FOR BASIC NEEDS SUCH AS TOILETING, FEEDING, AND MEDICATION ADMINISTRATION.

POOR HYGIENE AND INFECTION CONTROL

MEDICATION ERRORS AND MISMANAGEMENT

THESE INSPECTIONS IDENTIFY VIOLATIONS AND DEFICIENCIES THAT HELP DETERMINE THE QUALITY OF CARE PROVIDED. THE WORST NURSING HOMES IN CINCINNATI CONSISTENTLY RECEIVE POOR SCORES AND NUMEROUS CITATIONS IN THESE REPORTS.

FREQUENCY AND TYPES OF VIOLATIONS

THE MOST COMMON VIOLATIONS FOUND IN THE WORST NURSING HOMES IN CINCINNATI INCLUDE:

- FAILURE TO PREVENT PRESSURE ULCERS AND BEDSORES
- INADEQUATE STAFF-TO-RESIDENT RATIOS

IMPACT OF POOR NURSING HOME CONDITIONS ON RESIDENTS

HEALTH COMPLICATIONS AND INCREASED HOSPITALIZATIONS

CONSULTING HEALTHCARE PROFESSIONALS, SOCIAL WORKERS, AND OTHER FAMILIES CAN PROVIDE RECOMMENDATIONS AND WARNINGS ABOUT SPECIFIC NURSING HOMES. ONLINE REVIEWS AND COMMUNITY FEEDBACK ARE ALSO USEFUL RESOURCES.

CONSIDER SPECIALIZED CARE NEEDS

ENSURING THAT A NURSING HOME CAN ADEQUATELY ADDRESS SPECIFIC MEDICAL OR COGNITIVE CONDITIONS IS VITAL. FACILITIES LACKING EXPERTISE IN DEMENTIA CARE OR REHABILITATION SERVICES MAY NOT BE SUITABLE FOR CERTAIN RESIDENTS.
