## NOTABLE CASES OF WORST WEIGHT CUTS

HIS ATTEMPT TO MOVE TO A LOWER WEIGHT CLASS RESULTED IN SEVERE DEHYDRATION AND HOSPITALIZATION. THIS CASE SERVES AS A CAUTIONARY EXAMPLE OF THE DANGERS INHERENT IN DRASTIC WEIGHT CUTTING METHODS.

### RONDA ROUSEY (MMA)

RONDA ROUSEY, A FORMER UFC CHAMPION, WAS KNOWN TO UNDERGO CHALLENGING WEIGHT CUTS BEFORE HER FIGHTS. IN ONE OF HER BOUTS, SHE REPORTEDLY LOST SIGNIFICANT WATER WEIGHT THROUGH SAUNA SESSIONS AND SWEATING, WHICH AFFECTED HER ENERGY LEVELS AND PERFORMANCE. ALTHOUGH SHE SUCCESSFULLY MADE WEIGHT, THE PROCESS WAS CITED AS A CONTRIBUTING FACTOR TO HER LATER STRUGGLES IN THE OCTAGON.

### DAVID HAYE (BOXING)

DAVID HAYE'S ATTEMPT TO DROP FROM CRUISERWEIGHT TO HEAVYWEIGHT INVOLVED EXTREME WEIGHT MANAGEMENT TACTICS. HIS RAPID WEIGHT LOSS LED TO VISIBLE PHYSICAL DECLINE AND IMPACTED HIS ENDURANCE AND STRENGTH, ILLUSTRATING THE RISKS OF CUTTING LARGE AMOUNTS OF WEIGHT IN BOXING.

# NOTEWORTHY WEIGHT CUTTING FAILURES IN WRESTLING

COLLEGIATE AND INTERNATIONAL WRESTLERS OFTEN FACE INTENSE PRESSURE TO MEET WEIGHT REQUIREMENTS. THERE HAVE BEEN DOCUMENTED INCIDENTS WHERE WRESTLERS SUFFERED FROM FAINTING, HEAT STROKE, AND EVEN DEATH DUE TO EXTREME DEHYDRATION AND STARVATION TECHNIQUES EMPLOYED DURING WEIGHT CUTS.

## COMMON TECHNIQUES USED IN WEIGHT CUTTING

ATHLETES EMPLOY A VARIETY OF METHODS TO REDUCE THEIR BODY WEIGHT RAPIDLY BEFORE WEIGH-INS. THESE TECHNIQUES RANGE FROM DEHYDRATION TO SEVERE CALORIC RESTRICTION AND ARE OFTEN COMBINED TO ACHIEVE RAPID RESULTS.

### DEHYDRATION AND WATER MANIPULATION

DEHYDRATION IS THE MOST COMMON AND DANGEROUS METHOD OF WEIGHT CUTTING. ATHLETES RESTRICT FLUID INTAKE AND USE SAUNAS, HOT BATHS, AND SWEATING SUITS TO LOSE WATER WEIGHT QUICKLY. THIS APPROACH CAN REDUCE BODY WEIGHT BY SEVERAL POUNDS WITHIN HOURS BUT SEVERELY IMPACTS HYDRATION AND ELECTROLYTE BALANCE.

### CALORIC RESTRICTION AND FASTING

MANY ATHLETES IMPLEMENT DRASTIC CALORIC DEFICITS OR INTERMITTENT FASTING IN THE DAYS LEADING UP TO WEIGH-INS. THIS METHOD REDUCES GLYCOGEN STORES AND BODY FAT BUT CAN LEAD TO MUSCLE LOSS, FATIGUE, AND IMPAIRED COGNITIVE FUNCTION IF NOT MANAGED CAREFULLY.

### USE OF DIURETICS AND LAXATIVES

SOME COMPETITORS RESORT TO DIURETICS AND LAXATIVES TO INCREASE FLUID LOSS THROUGH URINE AND BOWEL MOVEMENTS. THESE SUBSTANCES CAN CAUSE DANGEROUS ELECTROLYTE IMBALANCES AND ARE OFTEN BANNED BY SPORTS REGULATORY BODIES DUE TO THEIR HEALTH RISKS AND POTENTIAL FOR MASKING OTHER SUBSTANCES.

### MANIPULATION OF FOOD AND SALT INTAKE

ADJUSTING SODIUM CONSUMPTION HELPS CONTROL WATER RETENTION. ATHLETES MAY REDUCE SALT INTAKE DAYS BEFORE WEIGH-IN TO MINIMIZE BLOATING AND WATER WEIGHT, BUT THIS REQUIRES PRECISE TIMING AND CAN AFFECT MUSCLE FUNCTION AND CARDIOVASCULAR HEALTH.

## HEALTH RISKS AND PHYSIOLOGICAL EFFECTS

## CARDIOVASCULAR STRAIN

RAPID WEIGHT LOSS INCREASES HEART RATE AND BLOOD PRESSURE VARIABILITY, PLACING EXCESSIVE STRAIN ON THE CARDIOVASCULAR SYSTEM. THIS CAN RESULT IN FAINTING, ARRHYTHMIAS, OR SUDDEN CARDIAC ARREST, PARTICULARLY WHEN COMBINED WITH PHYSICAL EXERTION.

## IMPAIRED COGNITIVE AND PHYSICAL PERFORMANCE

## REGULATORY MEASURES AND SAFETY PROTOCOLS
